This contest is open to legal residents of the State of Alabama who are 18 years of age or older at the time of entry and who possess a valid government-issued photo identification. 4. Each weekday during the promotional period, WZZK-FM will instruct listeners to call the radio station after hearing the 12 Working Days of Christmas cue to call to participate in the contest.
5. Immediately following the announcement, WZZK-FM will accept the 25<sup>th</sup> caller and that caller will become the official contestant for that individual game.
6. Once the official contestant has been selected, that caller automatically wins the prize of the day listed in section 1. b. of these official contest rules.

7. Any winning contestant must be the participant who originally dialed the phone to the radio station to participate in the contest. No family members, friends, office associates, or any other person will be allowed to participate in the contest on another person's behalf. The contestant must provide their own name and own social security number. If a contestant uses a false name or social security number, they will be immediately disqualified from the contest and be ineligible to win any prize, and such conduct may be considered fraud and may result in legal ramifications.
