## WBPT-FM 106.9 The Eagle Classic Rock Pay Off

## **OFFICIAL RULES**

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
- Eligibility. Subject to the additional restrictions below, the Classic Rock Pay Off (the "Sweepstakes") is open to residents of the state of Alabama who are 18 years or older at the time of entry". When you hear the "Classic Rock Pay Off Song of the Day", call Sponsor's Sweepstakes Line at 205-741-1069 to try to be the 10<sup>th</sup> caller. Subject to verification of eligibility and compliance with these Official Rules, the 10<sup>th</sup> person to call Sponsor's Sweepstakes Line, as solely determined by Sponsor, will become a Finalist.
