

## 2018 BOB FM Ultimate Summer Six Pack

### Official Rules

#### NO PURCHASE REQUIRED TO ENTER OR WIN.

1. **Eligibility:** The 2018 BOB FM Ultimate Summer Six Pack Giveaway is open to legal residents of Minnesota and Wisconsin and Iowa, who are 18 years of age or older at the time of entry. Employees and non-employee workers of Milestone Radio LLC, Lakes Broadcasting, StarCom LLC and their respective parent companies, subsidiaries, affiliates, and agents and those prize providers and agencies that are involved in the development or execution of this giveaway or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. The giveaway is subject to all applicable federal, state, and local laws and regulations and is void outside the listed states and where prohibited by law.

4. **Promotion Period:** The giveaway begins at 8:00 a.m. Central Time ("CT"), April 9, 2018 and ends at 5:30 p.m. CT, May 18th, 2018 (the "Promotion Period"). Milestone Radio LLC's computer is the official time-keeping device for this giveaway.
5. **How to Enter:** During the promotion period, a summer song of the day will be announced at 8:20 a.m. CT each weekday. When the announced summer song of the day is aired on BOB FM, caller number 6 will win the daily prize from No Name Steaks and they will be entered into the weekly drawing for the grand prize ultimate summer six pack. There will be a total of 30 daily prize winners. There will be a total of 6 grand prize winners. Limit: One (1) daily prize per person. Only one (1) daily prize per

household. One (1) entry into one (1) weekly grand prize drawing.

6. Grand Prize Drawing: Administrator is an independent judging organization whose decisions as to the selection of the potential winners are final and binding. The Weekly drawing for the grand prize will be drawn at 5:20p.m. CT each Friday during the promotional period. Each week will be a new drawing from that week's daily winners. 9. Publicity: Except where prohibited, participation in the giveaway constitutes the entrant's consent for the sponsor, each participating radio station, and its designees to use the entrant's name, likeness, prize information, city and state of residence for promotional purposes in any media form without further consideration.
