

DETAILED CONTEST RULES DRIVERS LICENSE NUMBER MATCH - RADIO:

1. How to Enter the Contest:

- a. The “Lucky Buck” contest will begin on Monday, September 12th and end on Friday, November 4th.
- b. To participate in the contest, listen for your “cue to call,” be the correct specified caller, and have a US Dollar Bill.
- c. Entrants may be disqualified at the sole discretion of Great Eastern Radio, LLC.

2. Eligibility Restrictions:

- a. The contest is open to all contest participants who are 18 years of age or older and are the holder of a valid United States issued One Dollar Bill, and legally reside in Vermont, New Hampshire, or Massachusetts.
- b. Employees, officers, and directors of Great Eastern Radio, LLC and Odds On Promotions, their respective affiliated companies, subsidiaries, distributors, dealers, retailers, printers, advertising, and promotion agencies, any and all other companies associated with this contest, and the members of the immediate families or households of any of the above are not eligible. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household.

3. Prizes:
