Saint J Subaru Grand Opening Car Giveaway: Official Rules

Eligibility Restrictions: This Sweepstakes is open to any resident in Vermont, New Hampshire, New York, Maine, Massachusetts, Connecticut, and Rhode Island who is 18 years of age and older. Timing: The Sweepstakes begins on July 3rd, 2017, at 12:00a.m. Eastern Standard Time (EST) and ends on July 28th, 2017, at 11:59 p.m. EST (the "Sweepstakes Period").

How to Enter the Sweepstakes: Entry forms can be completed in the dealership at Saint J Subaru and online at www.saintjsubaru.com. Eligible entries will include the entrant's full legal name, address, phone number, email address and birthdate. Only completed and accurate entries are eligible. The limit is one entry per person per day of the Sweepstakes, referred to as the "Contest Day", between 12:00 am EST and 11:59 PM EST from July 3rd, 2017 daily until July 28th, 2017.

Prize: On or after 8 am of every day after July 3rd, 2017, but not after July 29th, 2017, Saint J Subaru will randomly select from all eligible entries ten (10) entrants from each Contest Day to be finalists. These ten (10) entrants will be notified by one of the three contact methods completed in the entry (e.g., email, phone or address) that they have qualified for the Grand Prize drawing for a 2017 Subaru Impreza, with a Manufacturer's Suggested Retail Price (MSRP) of \$19,215 on July 29th, 2017.
