Brandon Neitzert, Agent, Division of Criminal Investigation, being first duly sworn upon oath, deposes and says:

On Friday June 22<sup>nd</sup> 2018 Heather Lynn Skinner DOB:12/09/1988 was found deceased on the bathroom floor of her residence located at 210 Hill Street in Yale, Beadle County, South Dakota. Beadle County Deputy Sheriff Chris Olerud arrived on scene and learned that Skinner's juvenile sons ages 4 and 6 had alerted a neighbor that their mother was not breathing and had been in the same position since an unknown black male, they identified as "the black man," had left the residence the night before.

DCI Agents executed a search warrant on the residence and body of Heather Skinner later the same day. Agents learned at this time Skinner's cellular phone had been removed from the residence. A ping trace on the device by the wireless carrier showed it was in Huron, a distance of 16 miles from Skinner's residence, and had last communicated with a tower in at 01:24 AM on June 22<sup>nd</sup>.

An autopsy conducted on June 25th concluded Skinner died of fentanyl toxicity with cocaine being a contributing factor, as well as supratherapeutic levels of Alprazolam (Xanax) in her system. A recent intravenous injection site was found on Skinner's right arm.

Skinner's juvenile sons, J.S. age 4, and J.S. age 6, were able to positively identify "the black man" from photographs associated with Skinner's Facebook account. I filed preservation requests with Facebook for records pertaining to Skinner's account, and the account associated with username "BiGgz Getitbyany

Means" from which the photograph originated. Additionally, from this photograph I was able to positively identify the male as Marc Woodley Henrisse.


On June 26<sup>th</sup> I met with Henrisse at the Huron Police Department for an interview. Henrisse admitted to meeting Skinner at her residence in Yale, SD on June 22<sup>nd</sup> for the purpose of purchasing some of her prescription Alprazolam medication. Henrisse admitted to taking some of the medication along with Skinner while at the residence. Henrisse admitted to watching the bathroom door to keep Skinner's children out while Skinner used intravenous narcotics. Henrisse admitted to knowing Skinner had overdosed on the narcotics and explained several measures he took to try to keep her awake and alert to include the use of ice to attempt to shock her system.

Henrisse stated his ride showed up to pick him up and he left the residence, leaving Skinner's juvenile children alone with Skinner in an unknown condition, but indicated she was still alert upon his departure. Henrisse stated that they stopped at Domino's Pizza in Huron and ordered a carryout pizza upon their return to Huron. Domino's surveillance video confirms a carryout order was placed at 12:52 AM and employees reported witnessing a silver Dodge Durango in the parking lot matching the description of the rental vehicle Henrisse confirmed he had been picked up in at Skinner's residence.

Search warrants for cellular phone record data for both Henrisse and Skinner provided location information for both devices placing them within proximity of each other on the 22<sup>nd</sup> of June. Matching Facebook records for both the accounts of Heather Skinner and Marc Henrisse detailed a text conversation between Henrise and Skinner beginning on June 20, and continuing on June 21, discussing "wanting to get high" and "intravenous" drug use. The conversation alludes to the distribution of drugs ("goodies," "Coca-Cola," "glass") and outlines a plan for Henrisse to travel to Yale to meet Skinner with the drugs.

Based on the above facts and circumstances probable cause exists to show Marc Woodley Henrisse, without any design to effect death, contributed to the death of Heather Skinner, while engaged in the commission of a felony.
