EQUAL EMPLOYMENT OPPORTUNITY AND DISCRIMINATION PREVENTION TRAINING UPPER LEVEL MANAGEMENT November 7, 8 & 9th, 2014

A training session was held for all upper level management of Noalmark Broadcasting Corporation on November 7, 8, and 9, 2014 in Santa Fe, New Mexico in conjunction with the Company's strategic planning and professional education annual meeting. This session was designed specifically to train management personnel on methods of ensuring sound equal employment opportunity (EEO) practices and preventing discrimination.

The managers attending the training session for Noalmark were Harry Harlan, Vice President and General Manager of Noalmark's Hobbs, NM stations; Aaron Forrister, Sales Manager of the Hobbs stations; Jay Helm, General Manager of Noalmark's El Dorado, AR stations; Paul Meacham, General Manager of Noalmark's Hot Springs, AR area stations; Kevin Bonner, General Manager of Noalmark's Roswell, NM stations; and Darryl Burkfield, Sales Manager of the Roswell stations. Company President, William C. Nolan, III along with Senior Vice President, Anna M. Canterbury conducted the session both of whom have extensive experience in EEO training, hiring and management.

Mr. Nolan reviewed Noalmark's EEO Policy Statement. It contains the Company's commitment to ensuring equal opportunity in employment and promotions for minorities and females. A copy of the company's EEO Policy Statement is attached for review.

Mr. Nolan and Mrs. Canterbury then reviewed in detail the FCC's EEO Policy which states that equal opportunity in employment shall be afforded to all persons, and that no one shall be discriminated against, regardless of race, color, religion, national origin or sex. Both the general and the specific EEO program requirements under the rules were presented and discussed. Prong Three Initiatives were discussed in detail, and each Manager presented examples of such initiatives taken so far this year. The FCC requirement to periodically self-assess and improve a station's EEO program was also discussed. The specific requirements of the self-analysis were discussed, to include a detailed review of the results and proposed enhancements. It was stressed that proper record keeping is very important, and record retention requirements of the FCC were reviewed.

There next ensued a presentation and discussion of the Managers' requirement to prepare an Annual EEO Public File Report. The components of the report were discussed in detail. It was stressed that if each station fulfilled its requirements on an ongoing basis throughout the year, and kept adequate records, that the Public File Report would be relatively easy to prepare.

The participants discussed how each manager could be more effective in complying with FCC requirements and the Company's own EEO Policy.

Mr. Nolan and Mrs. Canterbury then reviewed the Company's sexual harassment policy. What constitutes harassment and how to respond to it were discussed in detail with actual cases presented and discussed. If the Company's stations are sensitive to harassment issues, and if the policy is followed, the result will be fairer treatment of employees. For additional training, a DVD titled "Harassment and Discrimination in the Workplace" was viewed.

After a discussion of several other Company policies, to include the dress code and the computer policy, the meeting was adjourned.

Noalmark Broadcasting Corporation – Hot Springs, Arkansas Scholarship Program

The Noalmark Broadcasting Corporation Scholarship program offered students the opportunity to study the careers available in the radio broadcasting industry at the college of their choice. The Scholarship program chooses from applicants who express an interest in the radio industry.

Noalmark funded two \$250 Scholarships in Hot Springs to a male and female who were interested in pursuing broadcasting as a career. It is our goal that the scholarships offered by Noalmark Broadcasting Corporation will encourage students to explore the opportunities available in the radio broadcast industry.

Noalmark Hot Springs EEO Narrative Statement 2014 Public File Report

2014 saw very little change in the economy from 2013 it was still flat to down. No new industries moved into the City. Oaklawn Race track and Casino did spend over \$65,000,000.00 in upgrades but this did not increase the permanent job base.

We again experienced some unexpected turnover as we continue to try to find qualified people to help us move the stations forward. We now have 9 full time employees, consisting of 4 males and 5 females. Three of the females hold prominent positions at our stations: Traffic Director, Office Manager, and Marketing and Promotions Director. Our General Manager is a male minority. We hired a female minority in our sales department as advertising and creative person. When we seek applicants for our openings we continued to use local newspapers, local female and minority groups, and local web sites in addition to airing announcements on all our stations. In all of our employment advertising we also always state that we are and equal opportunity employer. We get very few to no applicants from the minority groups. In 2014 we participated in 2 local job fairs. Our General Manager was on the sites and explained our policies and discussed our openings. We will continue to review our contact groups as we do annually to try and become more effective.

Our Annual Self Assessment has been completed and is in the station files. It shows that we have done a great deal to inform, train and educate both our current and prospective employees about our EEO Policy and Commission Rules. As this report indicates, we take our EEO obligations very seriously. We have held training sessions for our upper level managers annually, as well as holding an annual meeting with all employees to review and familiarize them with FCC Rules and our own EEO commitments and obligations. The last meeting was held on December 29, 2014. A copy of our EEO Policy is attached to this Report. We run our stations in a manner that serves our communities.
