OFFICIAL RULES FOR SummitMedia, LLC Contesting

The following are the official rules of SummitMedia, LLC ("Sponsor") for the Sonic Temple Flyaway "Festival Flyaway Fever" Contest ("Contest"). By participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY. Void where prohibited by law. All federal, state, and local regulations apply.
- **ELIGIBILITY.** Unless otherwise specified, the Contest is open only to legal U.S. residents age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in a 50 miles radio of Wichita, Kansas listening area. Unless otherwise specified, employees of SummitMedia, LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the SummitMedia, LLC radio station's listening area, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. Only one winner per household or family is permitted. There is no limit to the number of times an individual may attempt to enter, but each individual may qualify only once per Contest. An individual who has won more than \$500 in a SummitMedia, LLC Contest or Sweepstakes in a particular calendar quarter is not eligible to participate in another SummitMedia, LLC Contest or Sweepstakes in that quarter unless otherwise specifically stated. Entrants may not use an assumed name or alias (other than a screen name where a contest involves use of a social media site). Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- **3. CONTEST PERIOD.** The Contest will begin Monday April 1, 2019 at 10:00am CT (Central Standard Time) and end on or about Saturday April 20, 2019 5:00pm CT (Central Standard Time). Sponsor's office computer is the official time keeping device for the Contest.

4. CONTEST AND HOW TO ENTER.

Starting Monday April 1, 2019 each weekday (Monday – Friday) during the sweepstake period, listeners have the chance to qualify 4 times per day when the official Festival Flyaway Fever cue to call is announced on air. Qualifying hours are Monday – Friday 10:00am CT – 5:59pm CT. Caller number 8 at 316-436-1095 after each cue to call will be named the qualifier, subject to verification of eligibility. 60 qualifiers will be solicited on-air via telephone entry.

On Saturday April 20, 2019 at 3:00pm CT, T95 will conduct the grand prize giveaway for this contest. At that time, 1 additional qualifier will be solicited via a register to win box. To enter, visit Emerson Biggins, located at 808 E. Douglas, Wichita, KS 67202 and submit a completed entry

form in the register to win box. Entries will be accepted 3:00pm CT – 4:00pm CT. Must be present to become the on-site qualifier. All on-location entries must be hand-written and original. Limit one on-location entry per person. Individuals who are discovered to have placed multiple entries into the entry box will be deemed ineligible. Immediate family members or same household members of a qualifier are not allowed to register. One qualifier will be solicited on location.

- a. For contests conducted on-air that allow telephone entry, at the time of their call, entrants must provide all requested information, including, their first name and last name, complete address, city, state, zip code, email address, telephone number, and date of birth. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Promoter. The contest administrator's telephone system is the official time keeping device for the Contest. Telephone responses to "cues to call" are only official when heard on-air via Sponsor.
- b. (NOT APPLICABEL FOR THIS CONTEST) For contests that allow entry by submission of a text entry or website entry, all entrants must follow the "call to action" entry instructions and submit any requested information. Entrants hereby expressly consent to the receipt of a confirmatory bounce-back message related to this contest. For text message contests, message and data rate may apply. The authorized account holder is the natural person who is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. Multiple entrants are not permitted to share the same text or mobile telephone number. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Promoter. The contest administrator's computer is the official time keeping device for the Promotion.
- c. (NOT APPLICABLE FOR THIS CONTEST) Each entry via Facebook, Instagram or Twitter must include requested information, including the entrant's first name and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth. Unless otherwise disclosed, no Contest is in any way sponsored, endorsed, administered by, or associated with Facebook, Instagram or Twitter. By submission of an entry, an entrant releases Facebook, Instagram or Twitter from any responsibility or liability for the Contest, prizes, or promotion. Entrants are providing entry information to the Promoter and not to Facebook, Instagram or Twitter.
- d. (NOT APPLICABLE FOR THIS CONTEST) For Contests entered online, entrants may be allowed the opportunity to enter multiple times, as disclosed on air, at the time of entry by clicking on the link displayed after the entrant has provided the requested entry information that allows the entrant to share an announcement about the Promotion via certain social media sites.
- 5. **TELEPHONE AND DELIVERY DISCLAIMER.** Participants are restricted to the use of ordinary telephone equipment. Participants that enable the "Caller ID" block function will not be allowed to participate unless they enter their correct area code and telephone number. The Company disclaims all liability for the inability of a participant to complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections,

acts beyond the Company's control, or otherwise. The Company disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any entry sent by mail, courier, express, email, text message, tweet, website posting, or other delivery method. The Company is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant's ability to participate in the contest, and any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in this contest. Due to the time delay that exists between a SummitMedia, LLC radio station's over-the-air signal and its online webcast, listeners who listen to a SummitMedia, LLC radio station online may hear Contest information or a cue to call later than listeners listening to the station's over-the-air signal. As a result, the odds of an online listener winning a Contest may be diminished.

6. WINNER SELECTION AND ODDS OF WINNING. Odds of winning a Contest prize depend on a number of factors, including, but not limited to, the number of eligible entries received by Sponsor during the Contest Period and the number of listeners participating at any given time. The odds of being chosen as a qualifier from the telephone method of entry depend on the number of callers for each cue to call. Odds of being chosen from the on-location method of entry depend on the number of on-location entries. The odds of winning the grand prize flyaway depend on the number of telephone qualifiers that end the finale event on Saturday April 20, 2019. Maximum odds would be 1 in 61.

Phone qualifiers will be advised of their qualifying status at the time of their call. The on-location qualifier will be notified of their qualifier status at the time of the drawing and must responds within 5 minutes. If he or she does not respond they will be disqualified and new on-location qualifier will be drawn from the remaining eligible entries.

Each qualifier will be asked to sign in at the finale event stating they understand the contest rules. They will also be asked to show a valid ID. If a qualifier refuses to sign in or show a valid ID, they are disqualified.

Qualifiers must be present at the finale event to win. Any qualifier who is not present at the event will be disqualified. The grand prize winner will be selected at the event in a reverse drawing format. Each qualifier will be given a number upon arrival. All numbers will be placed in the hopper. When each qualifier's number is drawn out of the hopper, that qualifier is disqualified. The qualifier whose number is the last number left in the hopper will be the grand prize winner.

The winning entrant will be awarded the prize subject to verification of eligibility and compliance with the terms of these rules or the specific Contest rules. Sponsor's decisions as to the administration and operation of the Contest and the selection of potential winners are final and binding in all matters related to the Contest. Any protest in the conducting of the Contest, the selection of the winners, or the awarding of prizes must be made within three days of the conclusion of the contest; the resolution of any protest shall be in the sole discretion of Sponsor, whose decision shall be considered final.

7. NOTIFICATION AND VERIFICATION OF POTENTIAL WINNER. POTENTIAL CONTEST WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules and/or the Office Rules of the Contest and winning is contingent upon fulfilling all requirements. The potential winner will be required to come in person to Sponsor's local office located at 4200 N. Old Lawrence Rd. Wichita, KS 67219 within 10 days of notification of winning during normal business hours, Monday through Friday, to provide proof of identity, execute an affidavit of eligibility, travel releases, and a liability/publicity release (except where prohibited), and a W-9 IRS Form, in order to claim his/her prize. A winner who executes these documents within the required time period will be deemed to have accepted the prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to provide the affidavit of eligibility and/or the liability/publicity release within the required time period, or if the prize or prize notification is returned as undeliverable, potential winner forfeits the prize. employees, or obtained from sources other than you; (3) you are verifying that you are the owner and producer of the submitted material and that no third party ownership rights exist to any material submitted, or, to the extent that any third party ownership rights exist, you have obtained all necessary licenses and/or clearances to use such third party content, and (4) you are hereby granting Sponsor a perpetual, worldwide, nonexclusive, royalty-free, sub-licensable (through multiple tiers) right and license to use, publish, reproduce, display, perform, adapt, modify, distribute, have distributed and promote such content in any form, in all media now known or hereinafter created, anywhere in the world, for any purpose.

- 12. TAXES. All State, Local, Federal and or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded in any Contest become the sole responsibility of the winner. Winners will be required to fill out and return an IRS W-9 tax form. Valuation of prizes may be based on information given to Sponsor by the provider of the prize. All those who win a prize or prizes over a certain threshold value in any given year may be issued an IRS Form 1099 to report their winnings.

To the extent a Contest involves use of a 3rd party website, application or platform, individuals should be aware that the third party's Privacy Policy may apply as well. Sponsor claims no responsibility for the actions of any such third party in the collection or use of your information. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of Sponsor to be used, disposed of or destroyed in its sole discretion. Sponsor is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to a SummitMedia, LLC radio station website.
- 17. CONSTRUCTION. The invalidity or enforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision were not contained therein.
