# 100.3 The X Rocks Sonic Temple Flyaway Official Contest Rules

No Purchase or Obligation Necessary to enter or win.

## **CONTEST DESCRIPTION:**

Contest Period: Beginning Monday, April 8, 2019 through Friday, April 19, 2019

**Requirements**: Winner and guest must be 21 years of age or older to qualify. Either winner or guest must be at least 25 years of age to rent a car from the airport to the venue.

**Grand Prize**: Two (2) grand prize winners will each win (1) One pair of 3 day passes to the Sonic Temple Music Festival in Columbus Ohio, Friday, May 17, 2019 through Sunday, May 19, 2019, plus (2) Two Round trip airfare and two (4) nights of hotel stay, provided by Eleven Seven Music, Republic Records, Epitaph Records and KQXR for promotional purposes. (ARV \$2000/per winner).

### **HOW TO ENTER/WIN:**

To participate in the Sonic Temple Music Festival Flyaway contest, listeners must do any the following:

- 1. Listen to KQXR Monday through Friday during the Contest Period at 7:30 am, 12:30 pm and 5:30 pm. To qualify, be Caller X and correctly answer the trivia question at (208) 287-1003. Caller X who answers the trivia question correctly will be qualified for the final drawing to be held Friday. There will be a total of 90 on-air qualifiers.
- 2. Telephone entries for this Contest may only be made using a single line per caller telephone system, and only callers using such a single-line calling system will be eligible to win or qualify to win. Contestants using, or attempting to enter this Contest using, any type of multiple-line calling system or auto-dialer, or any software that enables multiple simultaneous dials, will be ineligible to win and will not qualify to win, this Contest, or, in the Station's sole discretion, future contests the station broadcasts.
- 3. Listeners may also qualify at any Treasure Valley Tobacco Connection or Big Smoke locations from Monday, April 8<sup>th</sup> to Monday, April 22<sup>nd</sup>. Friday, April 24, 2019 from 5:00 pm to 7:00 pm at Tobacco Connection, located at 9846 W. State Street, Star ID 83669. 5 qualifiers will be chosen from all Tobacco Connection and Big Smoke Enter to Win boxes.
- 4. Five (5) last minute qualifiers will be drawn at the giveaway party Friday, April 26<sup>th</sup> at 6:00 PM.
- 5. Qualifiers must be present at the final giveaway party at Dave & Busters, located at

546 N Milwaukee St, Boise, ID 83704 and checked in no later than 5:55 PM. Random reverse Drawing will begin at 6:00 PM. Qualifiers may NOT send someone in their stead.

- 6. Each qualifier will receive a number at check-in, the ping pong ball with the corresponding number will be placed into the ball hopper. The last two balls drawn will win the grand prizes.
- 7. Winners plus guest must be at least 21 years of age at time of travel.

## **ELIGIBILITY RESTRICTIONS:**

- 1. The Sonic Temple Music Festival Flyaway contest is open to listeners of the Station who are 21 years of age and older and are legal residents of the 48 contiguous United States residing with the Boise, Idaho metropolitan area.
- 2. Employees of KTHI, KRVBR, KJOT and KQXR, Boise Lotus Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Boise metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this Sonic Temple Music Festival Flyaway contest. For purposes of this contest, immediate family members mean spouses, parents,
- 3. grandparents, children, and siblings and their respective spouses are not eligible.
- 4. Once an individual wins a prize in <u>this</u> Sonic Temple Music Festival Flyaway contest, they are not eligible to win another prize in <u>this</u> contest except as specified within these rules.
- 5. Persons who have won a prize in another contest or promotion of any kind from Boise Lotus within the seven (7) day period immediately preceding the start date of Sonic Temple Music Festival Flyaway contest are not eligible to participate. 1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KQXR and Boise Lotus Corp. - 2. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
