**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**  
**A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

1. PROMOTION DATES

These rules (the "Official Rules") govern, 94.9 The River, 107.1 K-HITS & J105 the My Dog's Got Talent ("Promotion"), which will begin on Saturday, October 3, 2020 at or around 12 AM MT and end at or around 12 AM October 25, 2020 (the "Promotion Period").

2. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all legal U.S. residents who are 18 years of age or older at the time of entry and who live within a 50 mile radius of Boise, ID (the "Promotion Area"). a. **Three (3) Grand Prizes: \$250 in dog accessories provided by Treasure Valley Subaru for promotional purposes, \$100 gift card to Zamzows (provided by Zamzows for promotional purposes) and winning dogs will be featured in future Treasure Valley Subaru advertisements. Video taping of winning dogs for future Treasure Valley Subaru Advertisements will be held Saturday, October 31<sup>st</sup> at Treasure Valley Subaru, located at 5605 E. Gate Blvd, Nampa, ID 83687. In the event of a tie, a random drawing will be held.**

b. Prizes are awarded as-is. There is no substitution, transfer, or cash equivalent for prize, except that Promoter may, at its sole discretion, substitute a prize of comparable value or cash. The prize is expressly limited to the item listed above and does not include taxes, licensing fees, or any other expenses. Promoter is not responsible for winner's limitations that prevent acceptance, use, or nonuse of prize. Entrants acknowledge that the Released Parties, as defined herein, have not made, nor are in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties expressed or implied, in fact or in law, whether now or hereafter enacted concerning prize, including without limitation, implied warranties of quality, merchantability, mechanical condition, or fitness for a particular purpose, except for any express manufacturer's warranty as may be included with the prize or as may be separately provided to participants by law.

#### 4. ENTRY

- a. **VIA Online** – To participate, visit any of the three station websites at [www.riverboise.com](http://www.riverboise.com), [www.khitsboise.com](http://www.khitsboise.com) and/or [www.j105.com](http://www.j105.com) during the entry period. Contestants will have between Monday, October 5, 2020 and Sunday, October 18<sup>th</sup> to upload their dog videos before the voting window begins. Voting begins Monday, October 19, 2020 and will end Sunday, October 25, 2020. Each individual participating in voting may vote only once, but may vote for up to three of their favorite video entries.
- b. Contestants must provide all requested information, including, their first name and last name, complete address, city, state, zip code, email address, telephone number and date of birth.

#### 5. CONDITIONS APPLICABLE TO ALL ENTRIES

- a. Use of any device to automate entry is prohibited. All entry information must be accurate. Proof of submission of an entry will not be deemed proof of receipt by Promoter.
- b. One Qualifier per immediate family and household, and each person may claim no more than one Qualifier position. If it is discovered that Qualifiers live in the same household, the last to qualify will be disqualified.

#### 6. QUALIFIER/WINNER SELECTION AND NOTIFICATION

- a. No more than three (3) entries may be submitted over the course of the contest dates for any contestant. The three (3) videos receiving the most audience votes will win one of the three (3) grand prizes and notified via phone or email on Monday October 25.
- b. Identification and Release of Liability and/or a Publicity Release will be collected from the three winners at the time of the videotaping of the dogs for use in advertising, at Treasure Valley Subaru on Saturday October 31, 2020. If any winner fails to do so by the deadline established by Promoter or fails to comply with the Official Rules (including eligibility requirements), winner will be disqualified and all prizes forfeited.

#### 7. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. Winners will be required to complete and submit an IRS Form W-9 or the equivalent including the winner's full Social Security number for receipt of prize. e. Promoter, in its sole discretion, reserves the right to disqualify any person (and all of their entries) from this Promotion if he or she tampers with the entry process, the operation of the Promotion, or the operation of Promoter's web channel or is otherwise in violation of the Official Rules or direction of Promoter. If a dispute arises regarding compliance with these Official Rules, Promoter may consider, in its sole discretion, data reasonably available to Promoter through information technology systems in Promoter's control, but Promoter will not be obligated to consider any data or other information collected from any other source. Promoter further reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the telephone portion of Promotion if it is not capable of completion as planned or if any fraud, technical failures or any factor beyond the Promoter's control, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort, corrupts or affects the administration, security, fairness, integrity or proper conduct of the telephone portion of the Promotion as determined by Promoter in its sole discretion. If Promoter does so, Promoter will not pick additional telephone Qualifiers after the termination and will announce its action on air.

f. For those viewing/listening to the Station stream on the Internet or other non-broadcast means: Please be advised that you may be listening to a delayed stream of the broadcast signal, which may vary depending on your computer's memory capacity and your connection. For that reason, we strongly recommend that you turn on your radio to the Station to participate in this Promotion to be sure you are participating in "real time." The Station assumes no responsibility for entrants not making timely phone calls to the Station as a result of the delays in the method of viewing/listening.

g.
