OFFICIAL RULES

1. PROMOTION DATES

- b. Contestants must provide all requested information, including, their first name and last name, complete address, city, state, zip code, email address, telephone number and date of birth.

5. CONDITIONS APPLICABLE TO ALL ENTRIES

a. Use of any device to automate entry is prohibited. All entry information must be accurate. Proof of submission of an entry will not be deemed proof of receipt by Promoter.
