# KTHI Valentine's Dedications Official Contest Rules

No Purchase or Obligation Necessary to enter or win

# **Contest Description:**

**Registration:** Beginning Monday February 3<sup>rd</sup>, 2020 through Friday February 7<sup>th</sup>, 2020 at 5:00 PM.

**Requirements:** Must be 18 years of age or older and have a valid Idaho Driver's License or Government Issued Identification Card.

**Prize:** One (1) Grand Prize Winner will receive one (1) 14K White Gold Sapphire & Diamond Halo Fashion Ring from Lee Read Jewelers (ARV \$1725.00). All prizes provided for promotional purposes.

### **HOW TO ENTER/WIN:**

Listeners of KTHI who are legal residents of the 48 contiguous United States residing within the Boise, Idaho metropolitan area will be able to take part in KTHI's Valentine's Dedications contest. To participate in the KTHI's Valentine's Dedications contest, listeners must do the following:

- 1. Starting Monday, February 3<sup>rd</sup>, 107.1 KHITS FM (KTHI) listeners will be directed to website to make their Valentine's Day Dedication. Collection will be open from Monday, February 3<sup>rd</sup> at 9am until Friday, February 7<sup>th</sup> at 5pm. All those that enter online will be in a random drawing for the grand prize from Lee Read (as listed above). Entries must include first and last name, phone number, dedication and song to be used for dedication.
- 2. Starting Monday February 10<sup>th</sup>, 2020, the top dedications will be played They will air throughout the day between February 10<sup>th</sup> and February 14<sup>th</sup>. Ten (10) dedications will receive a Mannheim Steamroller's Classic Romance CD (Romantic Melodies) provided by Daybreak Entertainment for promotional purposes (approximate value \$15). Top ten dedications will be determined by KTHI on air staff based creativity.
- 3. The Grand Prize winner will be drawn and announced during the morning show on Friday, February 14, 2020.

## **ELIGIBILITY RESTRICTIONS:**

- 1. The KTHI Valentine's Day Dedications contest is open to listeners of KTHI who are 18 years of age and older and are legal residents of the 48 contiguous United States residing within the Boise, Idaho metropolitan area.
- 2. Employees of KQXR, KRVB, KTHI and KJOT, Boise Lotus Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Boise metropolitan area and members of immediate families or those living in the same households (whether

related or not) of any of the above are NOT eligible to participate or win in the KTHI's Valentine's Dedications contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.

3. Persons who have won a prize in another contest or promotion of any kind from Boise Lotus within the thirty (30) day period immediately preceding the start date of KTHI's Valentine's Dedications contest are not eligible to participate. Only one person per family or household (whether related or not) may win in any promotion from Boise Lotus during any thirty (30) day period.

It will be at the discretion of the KTHI's Valentine's Dedications contest sponsor and/or the contest administrator if another entrant is to be selected as the winner if time permits.
