

Request for Information



December 7, 2015

This is a request for information that will cover several city employees, and three commissioners and the city Attorney.

- 1. I request the payroll records of Officer Swenson including his overtime hours for the last 12 months.
- 2. What is the status of the allegations that officer Swenson had sexual relations while on duty?
- 3. Commissioner Nielson is the portfolio holder for the police department, has she at any time ever received any information concerning Chief Thompson, that she did not share with the rest of commissioners. Information from his (Thompson) previous employer BCI or any other source?
- 4 When did you as city administrator receive information concerning sexual harassment allegations concerning Chief Thompson?
- 5. What is the status of your investigation concerning these allegations?
- 6. Commissioner Pedersen along with his business partners purchased a apartment complex from Mr. Gaukler, Mr Gaukler is selling this property on a contract for deed or similar financial arrangement this is a conflict of interest. What does the city intend to do about this conflict?
- 7. Commissioner Magnuson was the guest of KLJ at a tail gating party in Fargo for a ball game. This is also a conflict of interest and would seem to be against the Valley City employee hand book. What are your intentions concerning this conflict of interest?

- 8. In 2013 you where told by the commission to give all Valley City employees a 2% raise and get with the department heads to determine which employees would get an additional 1% pay increase for doing a good job. Why did you give all Valley City employees a 3 % raise which was contrary to your instruction from the commission.
- 9. After the last flood here in Valley City you told the commission that no flood homes could be moved within the city limits. I would like you to be specific and quote which N.D.C.C. or International Building Code regulation or FEMA regulation that you used to make such a statement about flood homes not being able to be moved within the city limits of Valley City.
- 10. Would you explain which federal regulation required Valley City to switch to the new smart meters. You mentioned something about the government was going to not allow Valley City to use some frequency. Could you be specific in your explanation and include a copy of the regulations and authorizing authority discontinuing the use of the frequency in question.
- 11. As city administrator did you know that Officer Swenson refused to take a lie detector test concerning an allegation of a forgery charge? If so when did you know about this charge?
- 12. Did Commissioner Nielson know about Officer Swenson refusal to to take a lie detector test concerning a forgery charge.
- 13. I would like you to investigate Commissioner Nielsons involvement in the hateful web site that was done to discredit three other people running for office.
- 14. Are you aware that officer Swenson is dating a woman who's name is Amy I do not want to use her last name. She is not the issue nor is the fact that they are dating, the issue is Swenson busted her husband for DWI and was sent to prison. The allegation here is

Swenson and Amy conspired together to bust her husband. And that Swenson has done this before, in a simular situation. I will expect those allegations to be investigated.

15. There has been new allegations concerning the current City Attorney buying alcohol for miners. There will be a criminal compliant filed this week with the Barnes County Sheriffs Office. You do not have to comment on this allegation I just wanted you to know about it.
