The Barnes County State's Attorney charges:

[¶1] Count 1: That on or about December 30, 2016, in Barnes County, North Dakota, the defendant, William Skywalker Weatherford, did commit the offense of **Criminal Vehicular Injury**, in violation of North Dakota Century Code section 39-08-01.2(2), by then and there: The defendant violated section 39-08-01 or equivalent ordinance and, as a result, caused substantial bodily injury or serious bodily injury to another, in particular: The defendant was driving while intoxicated, which caused substantial bodily injury or serious bodily injury to A H . This offense is a **Class C Felony**. This replaces citation number 1150200372.

The defendant pled guilty to driving under the influence in violation of N.D.C.C. § 39-08-01 on May 29, 2014 in case number 02-2014-CR-00148.

[¶2] Count 2: That on or about December 30, 2016, in Barnes County, North Dakota, the defendant, William Skywalker Weatherford, did commit the offense of **Criminal Vehicular Injury**, in violation of North Dakota Century Code section 39-08-01.2(2), 39-08-01, by then and there: The defendant violated section 39-08-01 or equivalent ordinance and, as a result, caused substantial bodily injury or serious bodily injury to another, in particular: The defendant was driving while intoxicated and cause substantial bodily injury or serious bodily injury to J S . This offense is a **Class C Felony**.
