CRIMINAL INFORMATION

The Barnes County State's Attorney charges:

[¶1] Count 1: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Possession with intent to manufacture or deliver a controlled substance**, in violation of North Dakota Century Code section 19-03.1-23(1)(a), 19-03.1-07(5), 12.1-32-01(3), by then and there: The defendant willfully possessed with the intent to manufacture or deliver a controlled substance, namely Methamphetamine, in particular: The defendant possessed methamphetamine with intent to sell or deliver to others. This offense is a **Class B Felony**.

[¶2] Count 2: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Unlawful possession of drug paraphernalia**, in violation of North Dakota Century Code section 19-03.4-03(1), 12.1-32-01(4), by then and there: The defendant used or possessed with the intent to use drug paraphernalia to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain or conceal a controlled substance, and the drug paraphernalia was used or possessed with the intent to use to manufacture, compound, convert, produce, process, prepare, test or analyze a Schedule I, II, or III controlled substance, other than Marijuana, in particular: The defendant possessed a scale with white residue. This offense is a **Class C Felony**.

[¶3] Count 3: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Fleeing a peace officer**, in violation of North Dakota Century Code section 39-10-71(1), 39-10-71(2), 12.1-32-01(4), by then and there: The defendant was a driver of a motor vehicle and willfully failed or refused to bring the vehicle to a stop, or otherwise fled or attempted to elude, in any manner, a pursuing police vehicle or peace officer, when given a visual or audible signal to bring the vehicle to a stop and the defendant was fleeing after or in the commission of a felony, in particular: The defendant refused to stop when being pursued a law enforcement vehicle with activated emergency lights, while committing the offense of possession of meth with intent to deliver. This offense is a **Class C Felony**.

[¶4] Count 4: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Reckless endangerment**, in violation of North Dakota Century Code section 12.1-17-03, 12.1-32-01(5), by then and there: The defendant willfully created a substantial risk of serious bodily injury or death to another, in particular: The defendant drove a vehicle in excess of 80 mph in a 25 mph zone, with other vehicles present. This offense is a **Class A Misdemeanor**.

[¶5] Count 5: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Unlawful possession of a controlled substance**, in violation of North Dakota Century Code section 19-03.1-23(8)(a), 19-03.1-11(4), 19-03.1-23(8)(b), 12.1-32-01(5), by then and there: The defendant willfully possessed a controlled substance, namely a Schedule IV Depressant, without a valid prescription, in particular: The defendant possessed Clonazepam without a prescription. This offense is a **Class A Misdemeanor**.



[¶6] Count 6: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Unlawful possession of a controlled substance**, in violation of North Dakota Century Code section 19-03.1-23(8)(a), 19-03.1-05(5), 19-03.1-23(8)(d), 12.1-32-01(6), by then and there: The defendant willfully possessed a controlled substance, namely Marijuana. This offense is a **Class B Misdemeanor**.

[¶7] Count 7: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Brett Allen Kohn, did commit the offense of **Driving under suspension**, in violation of North Dakota Century Code section 39-06-42(1), 12.1-32-01(6), by then and there: The defendant operated a motor vehicle on a highway or on public or private areas to which the public has a right of access for vehicular use in this state while the defendant's license is suspended or revoked in any jurisdiction. This offense is a **Class B Misdemeanor**.

[¶8] Against the peace and dignity of the State of North Dakota.



[¶1] Count 1: That on or about January 19, 2018, in Barnes County, North Dakota, the defendant, Adam Christian Rittenhouse, did commit the offense of **Refusal to halt**, in violation of North Dakota Century Code section 12.1-08-11, 12.1-32-01(6), by then and there: The defendant willfully failed or refused to stop or otherwise fled or attempted to elude, in any manner, a pursuing peace officer, when given a visual or audible signal to stop, in particular: The defendant fled on foot after being pursued by law enforcement vehicles with activated lights. This offense is a **Class B Misdemeanor**.

[¶2] Against the peace and dignity of the State of North Dakota.
