## Proclamation

### TEMPORARY BURN BAN BARNES COUNTY, NORTH DAKOTA

April 25, 2019

**WHEREAS, Barnes County, North Dakota is under abnormally dry Conditions; and**

**WHEREAS, the impact of fires could threaten the health, well-being, and safety of citizens in Barnes County; and**


**WHEREAS, the cost of response and the inordinate equipment wear may be far in excess of available county resources.**

**NOW, THEREFORE, BE IT RESOLVED, that the Board of Barnes County Commissioners declare a Temporary Burn Ban for Barnes County, North Dakota until further notice. This includes the burning of leaves, grass clippings, garbage/pits, construction debris, fallen trees, crop residue or hay land, sloughs, and campfires/bonfires.**

**ANY INDIVIDUAL WHO WILLFULLY VIOLATES THIS BURN BAN IS GUILTY OF A CLASS B MISDEMEANOR, WHICH CARRIES A PENALTY OF UP TO THIRTY (30) DAYS IN JAIL AND A \$1,500.00 FINE PER INCIDENT, AS WELL AS THE COST FOR FIRE SUPPRESSION.**
