The Barnes County State's Attorney charges:

- [¶1] <u>Count 1</u>: That on or about a time period between November 1, 2021 and November 5, 2021, in Barnes County, North Dakota, the defendant, Jeremy Wade Hatcher, did commit the offense of **Aggravated assault-Domestic violence**, in violation of North Dakota Century Code section 12.1-17-02(1)(b), 14-07.1-01, 12.1-17-13, 12.1-32-02.1, 12.1-32-01(4), by then and there: The defendant knowingly caused bodily injury or substantial bodily injury to a family or household member with a dangerous weapon or other weapon, the possession of which under the circumstances indicates an intent or readiness to inflict serious bodily injury, in particular: Defendant knowingly caused bodily injury to J.B., a family or household member, with a crowbar, the possession of which under the circumstances indicates an intent or readiness to inflict serious bodily injury. This offense is a **Class C Felony.**
- [¶2] <u>Count 2</u>: That on or about December 3, 2021, in Barnes County, North Dakota, the defendant, Jeremy Wade Hatcher, did commit the offense of **Terrorizing-Domestic violence**, in violation of North Dakota Century Code section 12.1-17-04(1), 14-07.1-01, 12.1-17-13, 12.1-32-01(4), by then and there: The defendant, with intent to place a family or household member in fear for that human being's or another's safety, or in reckless disregard of the risk of causing such terror, threatened to commit any crime of violence or act dangerous to human life, in particular: Defendant threatened to kill J.B., a family or household member. This offense is a **Class C Felony.**
- [¶3] <u>Count 3</u>: That on or about December 3, 2021, in Barnes County, North Dakota, the defendant, Jeremy Wade Hatcher, did commit the offense of **Unlawful possession of a controlled substance**, in violation of North Dakota Century Code section 19-03.1-23(7)(a), 19-03.1-23(7)(b), 19-03.1-07(5), 12.1-32-01(4), by then and there: The defendant willfully possessed a controlled substance, namely Methamphetamine, this being a second or subsequent offense, in particular: Defendant possessed methamphetamine and has a prior requisite conviction in case 02-2018-CR-00250. This offense is a **Class C Felony.**
- [¶4] <u>Count 4</u>: That on or about December 3, 2021, in Barnes County, North Dakota, the defendant, Jeremy Wade Hatcher, did commit the offense of **Domestic violence**, in violation of North Dakota Century Code section 12.1-17-01.2(2)(a)&(1)&(3)(a), 12.1-17-13, 12.1-32-01(5), by then and there: The defendant willfully caused bodily injury to a family or household member, this being a second or subsequent offense, in particular: Defendant willfully caused bodily injury to J.B., a family or household member, by headbutting J.B., and the defendant has a prior requisite conviction in case 02-2013-CR-00564. This offense is a **Class A Misdemeanor**.
- [¶5] <u>Count 5</u>: That on or about a time period between November 10, 2021 and November 15, 2021, in Barnes County, North Dakota, the defendant, Jeremy Wade Hatcher, did commit the offense of **Domestic violence**, in violation of North Dakota Century Code section 12.1-17-01.2(2)(a)&(1)&(3)(a), 12.1-17-13, 12.1-32-01(5), by then and there: The defendant willfully caused bodily injury to a family or household member, this being a second or subsequent offense, in particular: Defendant willfully caused bodily injury to J.B., a family or household member, by inflicting bodily injury on J.B. with a curtain rod, and the defendant has a prior requisite conviction in case 02-2013-CR-00564. This offense is a **Class A Misdemeanor**.
- [¶6] <u>Count 6</u>: That on or about a time period between November 17, 2021 and November 22, 2021, in Barnes County, North Dakota, the defendant, Jeremy Wade Hatcher, did commit the offense of **Domestic violence**, in violation of North Dakota Century Code section 12.1-17-01.2(2)(a)&(1)&(3)(a), 12.1-17-13, 12.1-

32-01(5), by then and there: The defendant willfully caused bodily injury to a family or household member, this being a second or subsequent offense, in particular: Defendant willfully caused bodily injury to J.B., a family or household member, by inflicting bodily injury upon J.B.'s ribs, and the defendant has a prior requisite conviction in case 02-2013-CR-00564. This offense is a **Class A Misdemeanor**.
