The Barnes County State's Attorney charges:

- [¶1] <u>Count 1</u>: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Burglary**, in violation of North Dakota Century Code section 12.1-22-02(1), 12.1-22-02(2), 12.1-32-01(4), by then and there: The defendant willfully entered or surreptitiously remained in a building or occupied structure, or a separately secured or occupied portion thereof, when at the time the premises were not open to the public and the defendant was not licensed, invited, or otherwise privileged to enter or remain, with intent to commit a crime therein, in particular: Defendant willfully entered Smith Lumber Company, when at the time the premises were not open to the public, and while not licensed, invited, or otherwise privileged to enter, with intent to commit a crime therein, specifically theft of property. This offense is a **Class C Felony.**
- [¶2] <u>Count 2</u>: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Burglary**, in violation of North Dakota Century Code section 12.1-22-02(1), 12.1-22-02(2), 12.1-32-01(4), by then and there: The defendant willfully entered or surreptitiously remained in a building or occupied structure, or a separately secured or occupied portion thereof, when at the time the premises were not open to the public and the defendant was not licensed, invited, or otherwise privileged to enter or remain, with intent to commit a crime therein, in particular: Defendant willfully entered Bjornson Golf Course, when at the time the premises were not open to the public, and while not licensed, invited, or otherwise privileged to enter, with intent to commit a crime therein, specifically theft of property. This offense is a **Class C Felony.**
- [¶3] <u>Count 3</u>: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Theft of Property**, in violation of North Dakota Century Code section 12.1-23-02(1), 12.1-23-05(3)(a), 12.1-32-01(4), by then and there: The defendant knowingly took or exercised unauthorized control over, or made an unauthorized transfer of an interest in, the property of another with intent to deprive the owner thereof, the value of that property exceeding one thousand dollars in value but not exceeding ten thousand dollars in value, in particular: Defendant took property of another, specifically Smith Lumber Company, with intent to deprive Smith Lumber Company of the property, and the value of the property was between \$1,000 \$10,000. This offense is a **Class C Felony.**
- [¶4] <u>Count 4</u>: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Theft of Property**, in violation of North Dakota Century Code section 12.1-23-02(1), 12.1-23-05(5)(a)(2), 12.1-32-01(6), by then and there: The defendant knowingly took or exercised unauthorized control over, or made an unauthorized transfer of an interest in, the property of another with intent to deprive the owner thereof and the property did not exceed five hundred dollars in value, in particular: Defendant took property of another, specifically James Jenson, with intent to deprive James Jenson of the property, and the value of the property was less than \$500. This offense is a **Class B Misdemeanor**.
- [¶5] Count 5: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Theft of Property**, in violation of North Dakota Century Code section 12.1-23-02(1), 12.1-23-05(5)(a)(2), 12.1-32-01(6), by then and there: The defendant knowingly took or

exercised unauthorized control over, or made an unauthorized transfer of an interest in, the property of another with intent to deprive the owner thereof and the property did not exceed five hundred dollars in value, in particular: Defendant took property of another, specifically Travis Gille, with intent to deprive Travis Gille of the property, and the value of the property was less than \$500. This offense is a **Class B Misdemeanor**.

- [¶6] <u>Count 6</u>: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Criminal mischief**, in violation of North Dakota Century Code section 12.1-21-05(1)(b), 12.1-21-05(2), 12.1-32-01(6), by then and there: The defendant willfully damaged tangible property of another, in particular: Defendant willfully damaged the property of Bjornson Golf Course. This offense is a **Class B Misdemeanor**.
- [¶7] <u>Count 7</u>: That on or about October 16, 2021, in Barnes County, North Dakota, the defendant, Jeffery Lee Hoganson, did commit the offense of **Criminal mischief**, in violation of North Dakota Century Code section 12.1-21-05(1)(b), 12.1-21-05(2), 12.1-32-01(6), by then and there: The defendant willfully damaged tangible property of another, in particular: Defendant willfully damaged the property of Smith Lumber Company. This offense is a **Class B Misdemeanor**.
- [¶8] Against the peace and dignity of the State of North Dakota.
