**NARRATIVE:** A Pontiac G6 was traveling north bound on Highway 1. A 1986 Diamond Coach motorhome was stopped at the intersection of Highway 1 and Highway 46. The Pontiac G6 continued northbound, and the driver of the motorhome failed to yield upon entering Highway 1 striking the G6 on the driver side. The motorhome pushed the Pontiac into the northeast corner of the intersection causing both vehicles to strike a light pole. The occupants of the Pontiac G6 were transported by ambulance to CHI Mercy Hospital in Valley City to be treated for their injuries sustained in the crash. The occupants of the motorhome were uninjured. The crash is under investigation by the North Dakota Highway Patrol.
