Superintendent Responsibilities:

1. Manage the exhibit check-in process, exhibition, and check-out process for their departments.
2. Arrange entries/exhibits to the best advantage of the exhibitors, spectators, and judges.
3. Review and interpret the rules and exhibition procedures with the department exhibitors, volunteers, and judge(s) before and/or during the exhibition.

GENERAL RULES AND REGULATIONS

1. All vehicles whose purpose it is to advertise in any way whatsoever shall pay the regular concession privilege rate.
2. Each person or firm selling or delivering merchandise on the grounds will be required to make arrangements with the Secretary.
3. 4-H and FFA families wishing to place campers on the fairgrounds during fair week shall register their camper/vehicle at the County Extension office before June 1.
4. FAIR WEEK EXHIBIT SPACE RENTAL RATES ON GROUNDS: All booths \$100. Excludes food and t-shirt vendors. Vendors wanting to sell t-shirts or food must complete a separate agreement with additional costs.
5. Any exhibitor making false statements in regard to any animals or articles exhibited, or attempting to interfere with judges in the performance of their duties, by any means, shall be excluded from competing or exhibiting on the grounds of the Association.
6. All exhibitors are expected to be cooperative and courteous. Any action to the contrary may result in the disqualification of the exhibitor, exhibit, and/or participation in the event.
7. Judges shall not consider any article or animal not properly entered and approved by the superintendent(s).
8. Lack of competition shall not be cause for withholding a premium if animal or article is deemed worthy. The judge's decision is final.

GROUND'S REGULATIONS

1. The Fairgrounds police will be sworn in as conservators of the law, and it shall be their duty to arrest any persons creating a disturbance or violating any rules of the Association.
2. No concession may be set up until concession fee, light bill and wiring charge have been paid in full to the Secretary.

3. Any privilege or concession obtained under false representation or does not conform with the applicable laws/ordinances will be revoked by management and any/all money paid for the same will be forfeited to the Association.
4. Soliciting for subscriptions for any newspaper or periodical will not be permitted unless from a space rented from the Association.
5. The management reserves the right to exclude from the grounds any person or persons who may seem undesirable or expel from the grounds such person or persons who shall violate any rules. No objectionable features will be tolerated.
6. Absolutely NO ALCOHOL in barns.

USE OF FACILITIES AND TRACK

1. No persons, without authority of the Executive Committee, will be allowed to roll, scrape, drag or otherwise manipulate the track or use it when in a condition by which it may be injured.
2. Persons are strictly prohibited from running horses or vehicles of any kind on the track or any other parts of the grounds during the Fair, except by permission of the Association.
3. No intoxicated person or persons shall be allowed on the grounds any person or persons guilty of disorderly conduct shall be immediately expelled.
4. Bill posting privileges are reserved strictly for the Marion County Fair Association, its officers, agents or employees.
5. The Marion County Fair Association is not responsible for injury to any person or person's property having license privilege to exhibit on its fairgrounds or occupy space thereon. The aforesaid association and its officers shall in no manner be responsible therefore.

OPEN CLASS RULES

1. Exhibitors shall carefully consult the fair book and determine what department and which class you wish to enter. Only the official Open Class Entry Form will be accepted. The Association will not be responsible for incomplete entries. Send your entry form early. All exhibits must be properly tagged before the judge can consider them for premium.
2. All entry forms must be entered on the books of the Secretary at the fairgrounds office on or before Friday, June 29th, 2018 at noon.
3. Articles must be in place on the grounds at the time designated in the department rules. **Use the East door of Dyer Hudson.**
4. No article can be entered for premium in two or more different classes.
5. All articles entered must be exhibited in the proper class.
6. The Association will in no case be responsible for any loss or damage to exhibit articles.
7. Exhibitors, upon bringing their articles to the grounds, shall take them to the superintendent of the proper department(s) to be placed on exhibit.

8. No open class article will be taken from the grounds during fair week until Wednesday between 5:00 and 8:00 PM.
9. In case of protest of article or exhibitor, written notice must be given to the superintendent of the department during the day of judging for the article protested and written names of witness must be filed with the Secretary on the same day.
10. No judge will be allowed to judge a class in which he/she has articles on exhibition.
11. Any proposed changes shall be submitted to the secretary by January 1, 2019.

RULES GOVERNING EXHIBIT

1. Entry forms shall close Friday, June 29th, 2018 at noon.
2. Competition in this department shall be open to Marion County residents only.
3. All articles must be entered in the name of maker and made since August 1 of the previous year.
4. Entries must be ready for displaying with attached entry tags between 3-7 pm, July 12th (Thursday) and remain in place through the duration. Go to the East door of Dyer Hudson.
5. Absolutely no entry will be accepted without sturdy matting ready for placement. This includes photos and drawings. No glass or frames.
6. The management shall not be responsible for loss or damage of exhibits.
7. All exhibitors are responsible for delivery and pickup of entries. Pickup time is 5:00 to 8:00 P.M. Wednesday night. Variation from this rule may result in loss or damage of exhibit.
8. The judge's decision will be final. Judging will take place Friday at 1:00 p.m. Exhibits will be judged on excellence and originality. (Note: copyright laws)
9. An exhibitor may have only one entry in a class.
10. Amateur exhibitors may not show in the professional class.
11. Exhibits having no competition will not be awarded a premium unless judged worthy of one.

A Marion County Fair Entry Tag should be securely fastened to the mat on each exhibit on or near the upper corner. Photographs may be monotone or color. Photographs may be processed from negatives, slides, or digital cameras and computer manipulation programs. Photos must have been taken after August 1 of last year. Photos must be matted. Exhibitors may cut their own mounting boards, use inexpensive ready-cut window mats, or have matting done professionally. Photos should NOT be framed. Framed photos will not be judged. A series is a group of pictures or slides that are related or tell a step by step story. Slides should be numbered and/or displayed in sequence.

1. Competition in this department is open to Marion County residents only. Entries must be the products of the exhibitor and made in the home kitchen and not as a means of livelihood.
2. Entries shall close Friday, June 29th, 2018 at noon.

DYER HUDSON BUILDING EXHIBIT RULES

1. Exhibitors are limited to members enrolled in Marion County 4-H by May 15 who have completed grades 4-12 or that equivalent. Grade always refers to last grade completed unless otherwise stated. A member becomes ineligible to exhibit upon completion of the calendar year of high school graduation. Members must be:
 - a. grades 4-6 to be in the Junior Section
 - b. grades 7-8 to be in the Intermediate Section
 - c. grades 9-12 to be in the Senior Section.
2. FFA members are limited to having only photographs judged and exhibited at Dyer-Hudson.
3. Dyer-Hudson judging will take place on Thursday of fair week, from 9 am to Noon and 1-3:30 pm. Absolutely no exhibits will be accepted, entered, or judged before or after the scheduled time.
4. Entries are to be made at the time of evaluation. Members should plan to spend some time waiting for judge(s). Members will be evaluated by different judges for the various

subject matter areas, or if exhibitor has three or fewer exhibits, may have all exhibits judged by an express-line judge. Fourth graders will have the option to of going to the fourth-grade judge and may be judged on up to six items at a time, then will go to the back of the line if they have additional items.

- a. Members will first take all exhibits to the check-in table (to be sure that entry tags are attached and the entry form is complete).
 - b. After judging has been completed, members will go to the ribbon table for exhibit ribbons, and then will transfer all exhibits to the proper location in the building.
 - c. The 4-H Exhibit Entry Form is the only copy of the ribbon placings. If this form is lost, premiums will not be paid.
 - d. Cash premiums will be paid at **release time**. Premium money for any exhibits not checked out with authorization to be removed from Dyer-Hudson at official release time will be forfeited.
5. Any member who takes an exhibit from the fairgrounds or its display area, prior to release time will be ineligible to exhibit in that Department the following year.
6. Exhibit classes are broad categories. To plan exhibits, members are encouraged to use project guides, manuals, and program materials to determine goals and learning experiences. Some project manuals include specific exhibit suggestions and procedures. An exhibit can represent an idea, a part, or all learning involved in the respective project or program. The county Extension office has more information on exhibiting.
7. Exhibits that do not comply with the class description, size guidelines, copyright, safety, and approved methods will be disqualified and not put on public display.
8. Eligible exhibits are an outgrowth of the member's participation in the selected project or program. Exhibits may be done by an individual or group. Exhibits might be, but are not limited to, an actual product, poster, display box, report, notebook, model, DVD, DC, etc.
9. The exhibitor's goal and applicable exhibit standards will form the basis of the evaluation process. Evaluation criteria will include demonstrated learning, workmanship and techniques, and general appearance and design.
10. **Each exhibitor is required to complete a 4-H Exhibit Record for each exhibit**, questions are listed below, or a form is available at the Extension Office. Members using video or cassette tapes as a part of their county fair exhibits

should make arrangements with the Extension Office ahead of time to have equipment available or may bring their own equipment. Exhibitors should respond briefly to the following questions about the exhibit:

a. What did you plan to learn or do?

b. What steps did you take to learn or do this?

c. What were the most important things you learned as you worked toward your goal(s)?

d. What would you like to do in this project area next year?

e. If your exhibit is a Visual Art, Home Improvement, or Clothing exhibit the following needs to be completed: Please identify the design elements/art principles used the exhibit and how they are used. Check the Marion County Fairbook for requirements.

f. Copyright logos, designs, or trademark materials should not be used for exhibits on public display at a fair or other setting without written permission. If written permission has been obtained for an exhibit, it should be submitted with the exhibit.

See fair book page 4-H-6, rule #18

g. General Financial Summary

NOTE: Check for additional requirements in exhibit classes for food and nutrition, photography, and visual arts.

11. The exhibit is to be an outgrowth of work done to accomplish the goal(s) determined by the member or group during the current 4-H year.
12. Exhibits may be prepared by an individual member, team of members, or it may be the result of a group effort.
13. There is a limit of six (6) exhibits per class unless otherwise noted in department rules.
14. Each item in an exhibit must be securely labeled with the exhibitor's name and department number. Labels should be placed on the back of posters and cards, and in an inconspicuous place on other items. A completed Marion County Fair entry tag should be securely fastened to the main item in each exhibit on or near the upper right corner or in an easily seen location.
15. Due to security, exhibitors are discouraged from sending items that have special meaning and historical value as the exhibit or part of an exhibit. Marion County Extension will use diligence to insure the safety of articles entered for exhibition after their arrival and placement, but will not be responsible for damage or loss by fire, theft, etc.
16. Exhibit displays should be in proportion to the main item or idea being displayed. If the exhibitor chooses a display to illustrate what was learned, the following maximum size

guidelines apply:

- a. Posters and banners are not to exceed 24"x36"
 - b. Chart or graph boards and model displays, etc., are not to exceed 4'x4' in size. Maximum size is determined by measuring the flat (unfolded) dimensions.
 - c) Display boxes are not to exceed 28"x22" in height or width and 12" in depth. **Exception:** See Department 8 (Communications), Class 821, for the Poster Art requirements.
17. Endangered and threatened plants and animals (including insects), or songbird feathers and nests may NOT be used in any exhibit. Wildflowers taken from parks should NOT be used. It is illegal to possess songbird feathers or nests. Game animals "legally taken", such as pheasant, goose, duck, or quail, are acceptable.
 18. Copyrighted materials and designs may not be used in an exhibit that is presented as original work by the exhibitor. Exhibitors must include permission from the copyright holder/owner when using copyrighted materials. Exhibitors must give proper credit to the original source of all materials/designs used in exhibits.
 19. All exhibits, activities, and programs must represent appropriate safety procedures in the development of the exhibit during the evaluation process. This includes static exhibits and activities revolving around the Communications program.
 20. **Exhibits which do not comply with guidelines will not be accepted for entry, evaluation, or display at the Marion County Fair.**
 21. Low-cost exhibits of high quality will be given special recognition.
 22. STATE FAIR: All exhibitors are responsible to read and comply with the Iowa State Fair General Rules for the exhibit to be eligible for Iowa State Fair exhibition. Exhibits which do not comply with size guidelines, copyright, and safety procedures will not be accepted for entry, evaluation, or display at the Iowa State Fair.
 23. State Fair exhibits will be selected from those items exhibited by members who have completed at least 5th grade. A member may have only one exhibit selected for State Fair.
 24. Exhibits will be awarded premiums of blue, red, and white ribbon quality. Premiums, unless otherwise stated, will be as follows: Blue, \$3.00; Red, \$2.00; White, \$1.00.
 25. All judges' decisions are final.

DYER HUDSON DEPARTMENTS AND CLASSES

Department 1 – ANIMALS

Class 10101 – ANIMAL SCIENCE

An exhibit (other than the animal itself) that shows the learning about a large or small animal including beef, dairy cattle, dairy goats, dogs, horse & pony, meat goats, pets, poultry, rabbits, sheep and swine. Ownership of any animal is not required.

Class 20101 - HORSELESS HORSE PROJECTS

Breed Poster
Horse First-Aid Kit
Safety Poster
Horse Barn Design

Class 10102 - VETERINARY SCIENCE

An exhibit that shows learning about keeping animals healthy.

Department 2 – AGRICULTURE AND NATURAL RESOURCES

Class 10210 - CROP PRODUCTION

An exhibit that shows learning about the growth, use, and value of field crops.

Class 10220 - ENVIRONMENT AND SUSTAINABILITY

An exhibit that shows the connections between humans and their environment including energy, stewardship, conservation, entomology, fish and wildlife, or forestry. Includes collections.

Class 10230 - HORTICULTURE AND PLANT SCIENCE

And exhibit that shows learning about the growth, use, and value of plants, soils, small fruits, vegetable and flower gardens, plant nutrition, careers, etc. (Garden crops and herbs are exhibited in classes in the 4-H Horticulture Department under 4-H Livestock at the State Fair.) Vegetables should be prepared and displayed according to 4-H 462, "Harvesting and Preparing Vegetables for Exhibit".

Class 10235 – HOME GROUNDS IMPROVEMENT

An exhibit that shows learning about landscape plans, selection of landscape plants, ornamental garden features, home yard improvement, storage sheds, careers, etc.

Class 551A - VEGETABLE CONTAINER DISPLAY

Must include five or more different vegetable crops grown in the exhibitor's home garden. For this class, herbs will count as vegetable crops. More than one variety of any particular vegetable can be

displayed; however, not more than four items of the same vegetable can be displayed. For example, four tomatoes would constitute one vegetable, e.g. one large red slicing tomato, one cherry tomato, one yellow tomato, and one processing tomato. The amount of produce exhibited should fit into the container. The vegetables should be prepared for exhibit as instructed in 4-H-462, "Harvesting and Preparing Vegetables for Exhibit". Any decorative basket, box, or other decorative container, not larger than one-half bushel in size, can be used. The exhibit will be judged 75% for cultural perfection of the vegetables and 25% for decorative arrangement. For the educational benefit of the public, a file card must accompany the exhibit with each crop clearly labeled as to the variety.

Class 551B - FIRST YEAR EXHIBITOR'S CLASS

Plate of mixed vegetables exhibited by a 4-H member who has never participated in the Marion County Fair 4-H Horticulture Show before. Plate is to consist of one tomato, one onion, one pepper, and two other vegetables of the exhibitor's choice.

Class 551C - HERB COLLECTION

Collection of 4 different herb species (three sprigs each) to be displayed in four separate bottles of water. Specimens should include 3 stems of adequate length to reach the water level. Each herb species should be properly labeled.

Class 551D - JUMBO OR MOST UNUSUAL

Vegetables (one specimen)

Class 551E

Item Constructed from garden produce.

Class 551F - SCARECROW CLASS

Be creative

Class 551G - BUCKET OF FLOWERS

A 5-gallon bucket with flowers that have been grown by the exhibitor with a **card listing the variety of flowers, and light requirements** (sun or shade). This will be judged by the horticulture judge. After judging, all buckets will be placed outside Dyer-Hudson and Bingley Bldg. to enhance the appearance during the fair. Buckets will be sold with proceeds going to County Council activities.

State Fair Horticulture -

Entries must be made with the County Extension Office by July 1. Contact the Extension Office for more information.

Horticulture Special Rules:

Members are limited to six exhibits in this department. A member may exhibit no more than three (3) vegetable exhibits and no more than three (3) flower exhibits. In addition to plants, posters, folders, and displays are also appropriate exhibits. Each entry must show variety name. Omitting the variety name may cause lowering of placing.

Class 10240 - OUTDOOR ADVENTURES

An exhibit that shows learning about backpacking, biking, camping, canoeing, fishing, hiking or other outdoor activities.

Class 10250 - SAFETY AND EDUCATION IN SHOOTING SPORTS

An exhibit that shows learning about safe and responsible use of firearms and archery equipment or wildlife management. (The exhibit may not include actual firearms; archery equipment allowed if tips are removed from arrows).

Class 10260 - OTHER AGRICULTURAL AND NATURAL RESOURCES

An exhibit that shows learning about agriculture or natural resources and does not fit in any of the classes listed above.

Department 3 – CLOTHING EVENT

The following Clothing classes will be judged at Clothing Day on Friday, June 22, 2018:

***Each member is allowed to exhibit 2 garments per class for Clothing Day.**

Class 511F - CLOTHING SELECTION

Purchased Garment - All members enrolled in the Clothing project area encouraged to participate.

1. Outfits must be selected by the participants and must be purchased. The purpose of this program is to help youth develop skills in buying clothing, new or used. Gifts of clothing are not eligible.
2. Premiums: Purple \$15.00; Blue, \$5.00; Participation, \$3.00

Class 511G - \$15 CHALLENGE

All members enrolled in the Clothing project area encouraged to participate.

1. Purchase an outfit that represents the 4-H'ers goal or intended use for the selected outfit.
2. Outfits **must** be purchased from a garage sale, consignment store, or resale shop, such as Goodwill, Plush Pony, etc.
3. Cost of outfit must be \$15 or less, not including shoes,

accessories, or undergarments.

4. Receipts **MUST** be turned in with Clothing Event Form.
5. Premiums: Purple-\$15.00; Blue, \$5.00; Participation \$3.00.

Class 511H - FASHION REVUE

Constructed Garment - All members enrolled in the Clothing project are encouraged to participate.

1. Model an outfit the entrant has constructed, machine-knitted, hand-knitted, or crocheted during the current 4-H year.
 - a. Garments or outfits consisting of one to three pieces such as party clothes, tailored suits, vest, slacks, skirt, active sportswear, and/or coats are acceptable as Fashion Revue entries.
 - b. Blouses, shirts, and sweaters are usually considered as garments. If they are used to complete an outfit, they may be purchased or constructed.
 - c. All other accessories and undergarments may be made OR purchased.
2. Premiums: Purple \$20.00, Blue Ribbons \$10.00, all other entries \$5.00.

For State Fair:

1. Members must be Senior level (grades 9-12).
2. A 4-H member may participate in each Clothing Event class once at the State Fair.
3. Members may be selected to represent Marion County in the Clothing Event at the State Fair.

Department 4 – Communications EVENT

The following classes will be judged at Communications Day on Friday, June 22, 2018:

Firearms, ammunition, and knives (including models & replicas designed to closely resemble these items), are not allowed in 4-H communication events. Archery arrows without tips or with ends blunted are allowed. 4-H members should consider personal and public safety, as well as the safety of exhibit items, when preparing 4-H exhibits for fair.

Educational Presentations, Working Exhibits, and Extemporaneous Speaking Premiums:

1. Individual - Excellence \$8.00, Merit \$5.00
2. Team - Excellence \$12.00, Merit \$8.00
3. State Fair - \$8.00 per member + \$8.00 for one parent per presentation

Share-The-Fun Premiums:

1. State Fair Representatives - \$16.00 per entry

Class 811B - EDUCATIONAL PRESENTATION

1. The topic selection should be appropriate and should be an outgrowth of the presenter's 4-H experience.
2. Use of sanitary and safe procedures and methods is always important, particularly if food samples are available to the audience.
3. Educational presentations will be classified as follows:
 - a. **Junior** - 4th, 5th, 6th grade (both team and individual) should not exceed 15 minutes in length
 - b. **Intermediate/Senior** – 7th-12th grades (both team and individual) length should be determined by the content, but should not exceed 20 minutes.
4. The composition of educational presenters can be any combination of eligible Junior, Intermediate, and Senior 4-H'ers. A team consisting of youth that are of mixed grades must be entered in the class of the oldest member.
5. Educational presentations will be ranked according to quality to be decided by the judge(s).
6. Participants are encouraged to wear appropriate clothing representative of the 4-H program and/or the topic of the presentation. If clothing contributes to the topic being presented, this is acceptable and appropriate.

Class 811C - WORKING EXHIBIT

The subject should be an outgrowth of the 4-H member's 4-H project experience.

1. Member(s) will share knowledge, information, and skill with an audience in an informal, hands-on way. The audience will participate with youth as the instructor(s).
2. Working Exhibit Suggestions:
 - a. Best topics involve action.
 - b. Those involving food must observe sanitary and safe procedures.
 - c. Members might use a question to start, such as: "Would you like to know how to . . . ?"
 - d. When possible, it would be desirable to involve the audience in doing, feeling, tasting, smelling, judging, etc.
 - e. Many stages of the exhibit or product might be ready so that any step can be discussed.
 - f. The member's subject should be an outgrowth of his/her project experiences. Teaching the audience what they have learned.
3. Working exhibits will be classified as follows:

- a. **Junior** - 4th, 5th, 6th grade (both team and individual) should not exceed 15 minutes in length
 - b. **Intermediate/Senior** – 7th-12th grades (both team and individual) length should be determined by the content, but should not exceed 20 minutes.
4. The composition of working exhibit presenters can be any combination of eligible Junior, Intermediate, and Senior 4-H'ers. A team consisting of youth that are of mixed grades must be entered in the class of the oldest member, i.e., a team with a 5th grader and an 8th grader must be entered in the Intermediate/Senior class.
5. Working exhibits will be ranked according to quality to be decided by the judge(s).
6. Participants are encouraged to wear appropriate clothing representative of the 4-H program and/or the topic of the presentation. If clothing contributes to the topic being presented, this is acceptable and appropriate.
7. There is no limit on the number of working exhibits per club.

Class 811E - Extemporaneous Speaking Contest

Participants must have completed 9th grade, or the equivalent. Extemporaneous speaking encourages the development of the communication life skill through enhancing the ability to think, to organize, to speak and to answer questions readily by participating 4-H'ers before an audience.

1. Each participant will have 30 minutes of prep time.
2. Reference materials will be available to contestants during the 30 minute prep time.
3. Speech shall not be less than 4 or more than 6 minutes.
4. Five minutes additional time for related questions asked by judge.
5. Contestants are not to use any props, gadgets, posters, or audio visuals
6. A judges' critique/conference is included as part of the evaluation

Class 811D - SHARE-THE-FUN

Provides 4-H'ers an opportunity to share their skills and talents and to have fun.

1. Acts must not exceed 8 minutes in length or they will be stopped.
2. Provides an opportunity for 4-H members to perform before an audience, purely for the sake of enjoyment.
3. Skits, songs, stunts, short one-act plays, dances (folk, square, modern, tap) plus other entertainment are acceptable, but must be in good taste, sensitive to diversity and

- culture/ethnic traditions of Iowans and/or U.S. citizens.
- 4. Members will be awarded participation certificates, but no premium money.
- 5. If the act involves a whole club, at least 80% of participants must have completed 5th grade to advance to the State Fair.

For State Fair (Fair dates August 9-19, 2018)

- 1. Participants must have completed 5th grade.
- 2. Participants cannot be involved in another event such as Clothing Program, Livestock Show, or Livestock Judging during the half-day they are scheduled to participate in the 4-H Communications programs. Marion County participants in the State Fair 4-H Communication event will be scheduled by date availability.
- 3. All participants are required to attend an orientation session at the beginning of the half day they are scheduled to give their Educational Presentation, Working Exhibit, Share-the-Fun act, or Extemporaneous Speech.
- 4. Orientation times are:
 - a. Educational Presentations - 8:30a.m. and 1:00p.m.
 - b. Working Exhibits - 8:30 a.m. and 1:00 p.m.
 - c. Share-The-Fun - 11:40 a.m. and 4:40 p.m.
 - d. Extemporaneous Speech - 8:30a.m. and 1:00 p.m.
- 5. Working Exhibits given at State Fair by Juniors (grades 5-6) will be scheduled for 25 minutes. Those given by Intermediates and Seniors (grades 7-12) will be scheduled for 45 minutes.
- 6. Only presenters are allowed in the Educational Presentation, Working Exhibit, and Extemporaneous Speaking preparation rooms.
- 7. All 4-H participants in Educational Presentations and Working Exhibits will be given Certificates of Recognition. Seals of Merit will be presented to those giving outstanding presentations. Seals of Excellence will be presented to those giving superior presentations. Participation ribbons will be given to all Share-The-Fun participants.
- 8. 4-H'ers giving Educational Presentations, Working Exhibits, and Extemporaneous Speech will receive an Iowa State Fair 4-H T-shirt that they are encouraged to wear while presenting. However, if clothing contributes to the topic being presented, such as wearing a bee-keeper's outfit while doing a presentation on raising bees, this is acceptable and appropriate.

Department 5 – CRAFT-KITS, & PATTERNS
(Not eligible for State Fair)

Class 201A -

Limited to 3 exhibits per member Articles made from kits or pre-formed molds will be accepted in this class. Exhibits made from patterns in general fit into this class. Some traditional patterns, such as quilt patterns, where design decisions are evident will fit into the Visual Arts class for Original Art.

Department 6 - CREATIVE ARTS

Class 10310 - MUSIC

An exhibit that shows learning about musical performance, composition and arrangements, instruments, musical styles or history.

Class 10320 - PHOTOGRAPHY

An exhibit, either photo(s) or an educational display that shows learning about photography from choosing a camera to modifying your photo. Still photos only, not video.

Photography Special Rules:

1. Photographs may be either black and white or color. They may be processed from negatives, slides, or digital cameras and computer manipulation programs. Photographs must have been taken since your county fair of the previous year.
2. Photographs should be a minimum of 4"x6". Finished size (including mounting/matting) of single photographs should not exceed 11"x14". *Exception: Panoramic photos must not exceed 24" in length.*
3. All photographs must be printed on photographic paper.
4. Mounted photographs can be (a) flush-mounted [no board showing] on mounting board, or (b) with mounting boards [window mat or flat mount directly on board]. Exhibitors may cut their own mounting boards, use ready-cut window mats or have matting done professionally. 4-Hers are responsible for design decisions such as border, color and size. **Framed photographs (including floating frames) will not be judged.**
5. Non-mounted photos may be exhibited in a clear plastic covering.
6. A series is a group of photographs or slides [3 to 5] that are related or tell a step-by-step story. Photographs must be mounted together in story order or sequence. Slides should be numbered. Finished size of individual photographs in a series should not exceed 6" x 8".
7. Digitally altered photos should include a copy of the photo before changes.
8. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.

9. Photographs depicting unsafe practices or illegal activities will not be displayed.
10. There is a limit of three (3) individual photos per member and a limit of three (3) series of photos; this includes photos entered electronically in class 10303.
11. Photography Exhibitors must use the Photo Exhibit Label to provide required information for photo exhibits. Photo labels are available at the Extension Office.

10325 – DIGITAL PHOTOGRAPHY EXHIBIT

A photo or series of photos submitted electronically, not printed. Photos in this class will be submitted, viewed, evaluated, and displayed electronically.

Digital Photography Exhibit Special Rules:

1. Photographs may be either black and white or color.
2. Photographs will not be printed.
3. Entries may be a single photo or a series of photos. A series is a group of photographs (3 to 5) that are related or tell a step-by-step story. Series photo entries must have all photos in the series viewable at the same time.
4. Photos entered should be submitted in the highest resolution possible. A finished file size of 1 MB – 3 MB is recommended.
5. Photos should be submitted in an acceptable and commonly used format for ease of viewing.
6. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.
7. Photographs depicting unsafe practices or illegal activities will not be displayed.
8. Iowa State Fair 4-H photography exhibitors must use the Photo Exhibit Label to provide required information for photo exhibits. The Photo Exhibit Label may be submitted electronically with the photo entry.
9. Photos entered in this class will be evaluated on the same evaluation criteria used for printed photographs.
10. Exhibitors entered in 4-H Photography are not eligible to exhibit in the FFA Photography show and vice-versa.

Class 10340 - ALTERNATE/CREATIVE PHOTOGRAPHY

A single photography or photographic image that has been created with an alternative photographic process, or a photo graph that was creatively edited or modified beyond reality in a creative, imaginative and experimental way to make it more interesting and visually engaging. Could be a composite of multiple overlapped photographs.

1. Photograph/Image must be mounted on foam core no smaller than 4"x4" and no larger than 10" x 10" in height and width.

No matting and no framing is allowed, put your creativity into the photography!

2. Photograph/Image can be created from film negative, digital negative, or digitally manipulated in computer.
3. Photograph must be on photo paper, canvas, or other flat material.
4. Exhibit must have Photo Exhibit Label on back with required information for photo exhibits. Include information about the processes used.
5. Subject matter must be in good taste and be appropriate for public display in a 4-H setting, photographs depicting unsafe practices or illegal activities will not be displayed.

Class 10345 – PHOTOGRAPHY IDEA/EDUCATIONAL DISPLAY

An exhibit that demonstrates learning about photography that does not fit into any previous photography class. This class includes photos printed on canvas, fabric, ceramic, etc. as part of an educational display showing learning about printing techniques, display, merchandising, etc.

Class 10350 - VISUAL ARTS

Any exhibit that shows learning through original art, exploration of an art technique, or study of and other visual art topic.

Visual Arts Special Rules:

1. Exhibits made from kits or preformed molds will not be accepted. Exception: Preformed molds (greenware, whiteware) may be used to provide the appropriate surface for a process technique or application of original design.
2. If the exhibit is a finished art object, the source of inspiration of the design, design sketches, or other process for creating the object and design must be included.
3. Original works of art must be a creative expression of a design unique to the artist, or represent a significant modification to an existing design to make a new and original statement by the artist.
4. Exhibition of derivative works created by a 4-H'er is prohibited without the written permission of the original copyright holder/owner. Use of copyrighted or trademarked designs, images, logos, or materials in 4-H visual arts is prohibited unless written permission has been obtained from the copy right or trademark holder/owner. For additional information, see 4-H Exhibit Copyright Information at <http://www.extension.iastate.edu/4-H/projects/visualart.htm>

Art elements and principles of design are the foundation of design whether putting together fabrics for clothing and quilts, selecting fur-

nishings for a room, or creating a drawing. Design elements are line, shape, form, color, and texture. Design principles are balance, proportion, rhythm, emphasis, and unity. Information on elements and principles of design for clothing can be found at:

www.extension.iastate.edu/Publications/4-H634.pdf

When application of design elements and art principles must be explained, the following guidelines shall be used:

1. Members in grades 4-6 are encouraged to use a minimum of one design element within their exhibit. Youth must explain how the specified element is used in the exhibit. While not evaluated or given a higher ribbon placing for using more than one element, youth may discuss additional elements used in the exhibit.
2. Members in grades 7-8 are encouraged to use a minimum of two design elements within their exhibit. Youth must explain how the specified elements are used in the exhibit. While not evaluated or given a higher ribbon placing for using more than two elements, youth may discuss additional elements used in the exhibit.
3. Members in grades 9-10 are encouraged to use a minimum of one art principle and the element or elements used in the selected principle. Youth must explain how the element or elements are used to illustrate the selected principle. While not evaluated or given a higher ribbon placing for using more than one principle, youth may discuss additional principles and corresponding elements used in the exhibit.
4. Members in grade 11-12 are encouraged to use a minimum of two art principles and the elements used in the selected principles. Youth must explain how the elements are used to illustrate the selected principles. While not evaluated or given a higher ribbon placing for using more than two principles, youth may discuss additional principles and corresponding elements used in the exhibit.

Department 7 - FAMILY AND CONSUMER SCIENCE

Class 10410 - CHILD DEVELOPMENT

An exhibit that shows learning about children. Examples: child care, growth and development, safety and health, children with special needs, and careers in child development.

Class 10420 - CLOTHING AND FASHION – Constructed/Sewn Garments & Accessories

A constructed garment or accessory (sewn, knitted, crocheted, or other process) that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics, and clothing care. Exhibits must be intended to be worn by humans.

Class 10422 - CLOTHING AND FASHION –Purchased Garments & Accessories

Purchased garments or accessories that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics, and clothing care. Exhibits must be intended to be worn by humans.

Class 10424 – CLOTHING AND FASHION – Other Ideas/Educational Exhibits

Any other educational exhibit that shows learning about clothing and fashion including but not limited to design illustrations, exploration of clothing styles, careers, clothing care, etc.

*Outfits or accessories which will be worn during the Awardrobe Clothing Event may not be entered as a 4-H Iowa State Fair exhibit.

Class 10430 - CONSUMER MANAGEMENT

An exhibit that shows learning through savvy budgeting, comparison shopping, money management, and consumer rights and responsibilities.

Class 10440 - FOOD AND NUTRITION – Prepared and Preserved Product

An exhibit of a prepared or preserved food product that shows skills or learning about cooking, baking, eating and choosing healthy foods, safety practices, or food preservation through the making of a prepared or preserved food product. See HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" for additional information regarding prepared and preserved food products.

Class 10445 – FOOD AND NUTRITION – Educational Display

An educational exhibit (poster, report, display) that shows that skills or learning about cooking, baking, eating and choosing healthy foods, safety practices, or food preservation. See HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" for additional information regarding prepared and preserved food products.

Food & Nutrition Special Rules:

1. Any exhibit considered to be a food safety risk or portray a food safety risk will not be accepted, judged or displayed.
2. All food products/exhibits should be appropriate for human consumption.
3. Food product exhibits must be prepared, baked or cooked using only food grade utensils and containers.
4. Products that require refrigeration will not be accepted, judged or exhibited.
5. Meat jerky products are prohibited.
6. The recipe must be included for any prepared food exhibit;

- credit the source of the recipe.
7. Preserved foods must include the Food Preservation Exhibit Label. Only food processed after August 1, 2017 is acceptable. Current USDA and/or Iowa State University guidelines for home food preservation must be used.
 8. Preserved food exhibits must include two product samples. One will be opened for evaluation and discarded; the second will be placed on display and returned to the exhibitor. All perishable food products will be discarded when removed from display.
 9. Prepared foods should be placed on a firm disposable plate or flat cardboard. Place food product exhibit in a re-sealable plastic bag with entry tag fastened outside the bag.
 10. The use of alcoholic beverages in the preparation or production of 4-H food exhibits is NOT permitted.

Class 10450 - HEALTH

An exhibit that shows learning through food choices, safe activities and skills such as first aid and CPR, careers, and healthy lifestyle choices.

Class 10460 - HOME IMPROVEMENT

An exhibit that shows learning in planning, improving and caring for your home living space. Exhibits may include new or refinished/reclaimed/restored items.

Class 10470 - SEWING AND NEEDLE ARTS – Constructed Item

(sewn, knitted, crocheted, or other process) that shows learning and skill in sewing, knitting, crocheting, or other needle arts. May include the construction of household items such as pillowcase, curtains, table runners, quilts, wall hangings, or other items. Exhibits in this class are not intended to be worn by humans.

Class 10472 – SEWING AND NEEDLE ARTS – Other Ideas/ Educational Exhibits

Any other educational exhibit that shows learning about sewing and needle arts including but not limited to construction techniques, use and care of fabrics and fibers, design illustrations, decorative processes, careers.

Class 10480 - OTHER FAMILY AND CONSUMER SCIENCE

An exhibit that demonstrates learning about a family and consumer science topic that does not fit any previous Family & Consumer Science class listed.

Department 8 – PERSONAL DEVELOPMENT

Class 10510 – CITIZENSHIP

An exhibit that shows learning about or contributing to your community, your country or your world.

Class 10520 – COMMUNICATION

An exhibit that shows learning about written, oral, and visual communication skills in their many forms.

Class 10530 - COMMUNICATIONS POSTER

This component of the 4-H Communications program is to provide the opportunity for 4-H'ers to communicate to the public using the non-verbal form of communication on a poster. The objective is to provide the opportunity for 4-H'ers to tell a story or idea visually about 4-H to the general public.

1. Only one poster per 4-H'er may be entered.
2. All posters must be designed on, or affixed to, standard poster board or foam core board – size minimum of 14" x 20" or maximum of 15" x 22". Posters may be any medium: watercolor, ink, crayon, acrylic, charcoal, oils, collage...
3. Posters **cannot** be 3-dimensional. Materials used to make the poster may **not** extend more and 1/8 inch above the poster or foam core board.
4. Each poster **must** have the completed Poster Exhibit Entry Form attached to the back.
5. Posters **cannot** use copyrighted material or exact copies of other promotional designs, such as the Iowa 4-H Youth Conference theme logo.
6. 4-H'ers may include the 4-H clover in the poster.
7. The themes for "Communicating Through 4-H Posters" are:
 - a. 4-H is...(open to 4-H'ers interpretation)
 - b. Join 4-H
 - c. Your Passport to Adventure (2018 Iowa 4-H Youth Conference theme)
 - d. Nothing Compares to 4-H Moments (variation of the Iowa State Fair theme)
 - e. 4-H Grows...

Class 10540 - DIGITAL STORYTELLING

Any exhibit that demonstrates the application of technology to produce a creative movie/film/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques, or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video.

Class 10550 – LEADERSHIP

An exhibit that shows learning about leadership skills and influencing others in a positive way.

Class 10560 - SELF-DETERMINED

An exhibit that shows learning as part of your 4-H adventure and does not fit any other class.

Department 9 – Science, Engineering & Technology

Class 10610 - MECHANICS

Any exhibit that shows skills or learning about general mechanics or engineering solutions or that involve a combination of skills.

Class 10612 – AUTOMOTIVE

Repaired or restored vehicle

Class 10614 – ELECTRIC

Constructed or repaired article or educational display that shows skills or learning about electric wiring, appliances, lighting, electrical energy sources safety, etc.

Class 10615 – SMALL ENGINE

Repaired or restored operating engine or educational display or other type exhibit that shows skills or learning about small engines. This class includes repaired or restored lawn tractors, small motorcycles, go-carts, etc.

Class 10616 – TRACTOR

Repaired or restored tractor

Class 10618 – WELDING

Constructed item or educational display that shows skill or learning about welding.

Class 10620 - WOODWORKING

Any exhibit that shows learning about wood, woodworking techniques, and safe uses of woodworking tools and machines. Exhibits may include newly constructed or refinished/reclaimed/restored wood items.

Class 10603 – SCIENCE, ENGINEERING & TECHNOLOGY

Any exhibit that shows learning about or helps explain how science and technology help us interact with the world. Topics include aerospace, biological and chemical sciences, computers & networking, earth & climate, geospatial mapping (GPS/GIS), robotics, or any other application of Science, Engineering, or Technology.

ACCOMODATING YOUTH WITH SPECIAL NEEDS

Youth with special needs may require help in order to be fully included in the variety of programs available. Individuals who need modifications should contact the Marion County Extension Office at least two weeks prior to the fair. A plan will be developed to meet the needs of the individual.

GENERAL RULES

1. **All exhibitors are responsible for reading and understanding fair department rules before making entries.**
2. Exhibitors should wear appropriate dress while in the show ring. This consists of a blouse or T-shirt (those having a 4-H or FFA emblem are encouraged), dark blue jeans, and protective footwear (no sandals or sneakers). Horse and Dairy Show attire is listed with those departments.
3. All exhibitors are expected to be cooperative, courteous, and good 4-H representatives, both in the ring and in the barns. They are also expected to treat their animals in a humane manner. Any action to the contrary may result in the disqualification of the exhibitor, exhibit, prizes, premiums, and/or participation in the event.
4. **All exhibit entries must be made with the Extension Service by 4:00 p.m. July 1.**
5. Any situation relative to 4-H Club and FFA exhibits not covered in the rules or in case of conflict or misunderstanding, final authority for interpretation rests with a board made up of a member of the fair committee, member of the county extension youth committee, one FFA advisor, one county extension staff member, and a superintendent of the division in which the dispute arises.
6. All Marion County 4-H and FFA members who have completed grades 4-12 are eligible to exhibit providing member cared for project a majority of the time. A member becomes ineligible to exhibit upon completion of the calendar year of high school graduation or equivalent. **Any time “grade” is stated in connection with a class, it means “last grade completed”.**

7. The following statement is taken from a Statement on Relationship between Iowa State University Extension Service and Iowa Public School Vocation Agriculture Program August 28, 1968, and will apply to Marion County: "Eligible youth may be members of either or both the 4-H and FFA. Separate projects shall be planned and conducted by the members of each group. The persons supervising the work are encouraged to plan projects and programs that will supplement each other in the broad development of the individual."
Livestock may NOT be identified as both a 4-H project and an FFA project.
8. In case of sickness, **an exhibitor may select a Marion County 4-H/FFA member of eligible age** to show his/her exhibit. **Substitution must be approved by the superintendent.** Same applies to exhibitors called into the armed forces. All showmanship exhibitors must show their own animals.
9. Any artificial means of removing or remedying physical defects, color, or conformation in exhibiting animals such as lifting or filling under the skin (no false tail heads), adding hair or twine, and artificial filling/drenching will be considered as fraudulent deception. All animals giving evidence of such treatment will be barred from exhibition at the Marion County Fair. The decision of the official fair veterinarian, appointed by the Fair Board, is final.
10. Exhibitors wishing to withdraw any animal on account of sickness must have approval of licensed veterinarian approved by Fair Board.
11. No animal will be in place before 1:00 p.m. Friday, or taken from its pen/stall before the scheduled release time during fair week **without receiving specific permission from the superintendent(s) beforehand..** ANY EXHIBITOR NOT COMPLYING WITH THIS RULE WILL RECEIVE NO PREMIUM AND THE EXHIBITOR MAY BE INELIGIBLE TO SHOW THE FOLLOWING YEAR.
12. **ALL EXHIBITORS SHALL REVIEW FAIR PROGRAM SCHEDULE FOR ARRIVAL, CHECK-IN AND RELEASE TIMES.**
13. Any flagrant abuse of over-entries can cause forfeiting of right to show.
14. In cases where there are few entries within a class, livestock judges reserve the right to make placings in accordance with the merit of the animal or animals concerned.
15. Numbers will be issued to each exhibitor. **Number is to be worn by exhibitor** for ease of identification and uniform appearance.

16. Any concerns or complaints over a project to be exhibited should be addressed to the Marion County Extension Office by June 30.
17. Sawdust bedding is provided by the County Fair Association to all barns. Used bedding must be disposed of in designated containers prior to leaving the grounds.
18. **All fans must have protective screens and safe wiring.**

LIVESTOCK SALE

1. All eligible market livestock (swine, beef, sheep, and meat goats) will be entered and sold in the Livestock Sale unless you notify the Extension Office BY 4:30 P.M. Tuesday of Fair Week. No sale list changes will be made after the deadline. All exhibitors are responsible for their animals' care before, during, and after the Livestock Sale until safely loaded on the buyer's truck.
2. Only market beef animals gaining at least 2 lbs./day are eligible for the sale. All swine not going to slaughter are subject to rule #6 of Health Requirements.
3. Please be helpful and cooperate with your Department Superintendents, Sale Officials, and Livestock Buyers. Sale officials may post additional requirements. As a seller of live stock you should be prepared to bring your animals promptly to the Sale Ring, present them for auction, and return them to their pen/stall or other location designated by the superintendents.
4. If selling more than one beef, notify office by 4:30 p.m. Tuesday which tag number is selling first.
5. **All non-sale pigs MUST be removed from the barn on Wednesday evening after 9 p.m.**
6. **Sale order for 2018 is Beef, Sheep, Goats and Swine.**

2018 Health Requirements for Exhibition of Livestock, Poultry and Birds at County 4-H/FFA Fairs

See additional rules in department rules

1. ANY EVIDENCE OF WARTS, RINGWORM, FOOT ROT, PINK EYE, DRAINING ABSCESES OR ANY OTHER CONTAGIOUS OR INFECTIOUS CONDITION WILL ELIMINATE THE ANIMAL FROM THE SHOW.
2. No individual Certificate of Veterinary Inspection will be required on Iowa origin animals or poultry exhibited at County 4-H/FFA FAIR, but the animals must be inspected when unloaded or shortly thereafter by an accredited veterinarian. All animals moving from out of state into an Iowa county 4-H/FFA fair must meet Iowa Animal and Livestock Importation requirements. Each show must have an official veterinarian.
3. Quarantined animals or animals from quarantined herds can not be exhibited.
4. Swine exhibitors at county fairs that do not require a Certificate of Veterinary Inspection, must sign and present an owner affidavit that the animals being exhibited did not originate from a quarantined herd and to the best of their knowledge; swine dysentery has not been in evidence in their herd for the past 12 months.
5. All swine exhibited must be accompanied by a record of a negative pseudorabies test, the test having been performed within 30 days prior to show, for swine originating from a Stage 4 or lower status county, subject to 64.35(2). No pseudorabies testing is required for swine originating from a Stage 5 county (Iowa is Stage 5).
6. Swine returning from an exhibition to its home herd or moved to a purchaser's herd, following an exhibition or consignment sale, must be isolated and retested negative for pseudorabies not less than 30 days and not more than 60 days after reaching the swine's destination. (Code of Iowa 166D.13(2))
7. EXCEPTIONS:
 - A. No testing is required for swine at an exhibition that involves only market classes, provided all swine are consigned directly to a slaughter establishment from the exhibition. The site that the swine originate

from must have a current monitored status in order for the swine to be transported to the fairgrounds (statistical testing completed within the last twelve months or originate from a site in Stage III or higher area). Swine leaving the exhibition from a market class must be consigned and moved direct to a slaughtering establishment.

B. If counties have a split show and the breeding animals are exhibited and returned home before the market classes arrive, it will not be necessary to have a test record on the animals showing in the market classes; however, market class animals must have a current monitored status in order to be transported to the fairgrounds.

8. SHEEP AND GOATS - All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag. All sexually intact goats must be identified with an individual Scrapie Flock of Origin identification tag or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG; 1-866-873-2824).
9. POULTRY AND BIRDS - All poultry(except doves and pigeons) exhibited must have had a negative Pullorum-Typhoid test within 90 days of public exhibition and the test must have been performed by an authorized tester.
10. However, "Market Classes" of poultry consigned to a slaughter establishment are exempt from the Salmonella testing requirements. "Market Classes" of poultry must be separated from all other poultry by a distance of ten or more feet and/or an eight-foot high solid partition.
11. DOGS AND CATS - All dogs and cats exhibited must have a current rabies vaccination certificate.
12. FARM DEER - "Cervidae" means all animals belonging to the cervidae family, and "CWD susceptible cervidae" means whitetail deer, blacktail deer, mule deer, red deer, elk and moose. Cervidae may be exhibited without other testing requirements when accompanied by a Certificate of Veterinary Inspection that lists individual official identification.
13. All Cervidae must have been part of the herd of origin for at least one year or were natural additions, or must have originated from a chronic wasting disease monitored or certified herd in which these animals have been kept for at least one year or were natural additions. Cervidae originating from a herd with a diagnosis, signs, epidemiological evidence, or area under quarantine for chronic wasting disease may not be exhibited. The following statement must appear on the Certificate of Veterinary Inspection:

A. CWD susceptible cervidae: "All Cervidae on this

certificate originate from a chronic wasting disease monitored or certified herd in which these animals have been kept for at least one year or were natural additions. There has been no diagnosis, signs, or epidemiological evidence of chronic wasting disease in this herd for the past year.”

B. Other cervidae. “All Cervidae on this certificate have been part of the herd of origin for at least one year or were natural additions to this herd. There has been no diagnosis, signs, or epidemiological evidence of chronic wasting disease in this herd for the past year.”

14. THE DECISION OF THE OFFICIAL SHOW VETERINARIAN WILL BE FINAL.

**2018 Beef Bred Classification for
IJBBA Sanctioned Shows**

To show an animal in a particular breed the entry must conform to the following rules established by their Iowa Breed Association: **NO FAX COPIES OF REGISTRATION PAPERS ALLOWED BY ANY BREED – NO EXCEPTIONS! REGISTRATION PAPERS MUST ACCOMPANY ANIMAL THROUGH CHECK-IN!**

American Aberdeen – All animals must be registered solely in the Junior Exhibitor's name, have readable tattoo's and registration papers in hand at check in. For more breed requirements contact Kevin Litchfield (515)432-8441. Breeding females must have 50% or greater American Aberdeen as their makeup. Steers must have 25% or greater or American Aberdeen as their makeup. Fullblood 100% American Aberdeen registered. Percentage Female; 50%-99.9%. Percentage Steers: 25%-99.9%.

Angus - Steers and heifers must have registration papers in hand at time of check-in; no fax copies will be accepted. Papers must be in the junior exhibitor's name. All animals must have readable tattoos. All exhibitors must follow the rules of the American Angus Association.

Charolais – Steers must be at least 50% or higher. The steer must have a certificate of recordation with the AICA and be 100% owned by the junior and in the exhibitor's name only. Purebred heifers registration papers must be 100% owned by the junior and in the exhibitor's name only.

Charolais Composite Heifer – Percentage heifers must be composed

of at least 50% and no more than 15/16 Charolais. Heifers must have a certificate of recordation with the AICA and it must be 100% owned by the junior and in the junior exhibitor's name only.

Chianina – All percentages of Chiangus, Chianina, Chimaine, Chiford and CAX (steers & heifers) that are able to be registered are eligible. They must be registered in the exhibitors name and have papers in hand at check-in.

Gelbvieh – Steers must be 50% Gelbvieh or more and exhibitor must have an official Gelbvieh breeder affidavit. Affidavits may be obtained from the American Gelbvieh Association website www.gelbvieh.org or contacting the AGA at 303-465-BEEF. Females must be registered and at least 75% Gelbvieh. Registration papers need to be in the exhibitor's name.

Balancers – Are 25% to 75% Gelbvieh with the balance Angus or Red Angus. Registration papers need to be in the exhibitor's name.

Herefords - (Polled or Horned) We are one association, but will have two separate heifer shows, steers will now be shown polled & horned as one division. Steers & Heifers must have registration papers in hand at time of check-in. Animals may be co-owned with siblings, provided each exhibitor is an individual National Junior Hereford member and a member of the Iowa Junior Hereford Association for the year of 2018. All exhibitors must follow the rules of the American Junior Hereford Association.

Limousin – Steers must be registered and be 50% or greater Limousin blood. Heifers must be 75% or greater Limousin blood and have an orange NALF registration paper. Must have registration papers in hand at check-in and be in the exhibitor's name.

Lim-Flex Females - Females registered as Lim-Flex with a purple NALF registration certificate will be eligible to compete. 75% Lim-Flex females are not eligible for the Limousin female show. Must have registration papers in hand at check-in and be in the exhibitor's name.

Maine Anjou – MaineTainer heifers will include $\frac{1}{4}$ to $\frac{5}{8}$ Maine Anjou females. High Percentage heifers will include $\frac{3}{4}$ and above females. Steers and MaineTainers no longer must be sired by a Maine Anjou registered bull. If your MaineTainer or Steer is registered with the AMAA, you will be able to show at all IJBBA shows from this point forward. If heifers are purchased at the 2018 Iowa Beef Expo and desire to show in the junior show, they must have been purchased through the Maine-Anjou sale. All exhibitors must have original registration papers in hand at time of check-in and papers need to be solely in the

junior exhibitor's name. All animals must have legible and correct tattoos. Exhibitor's must be a member of the Iowa Junior Maine-Anjou Association and pay a \$10.00 annual fee. All exhibitors must follow the rules of the American Junior Maine-Anjou Association.

Polled or Horned Miniature Herefords - Miniature Herefords will show both polled and horned heifers together and polled and horned steers together. Heifers must have registration papers and Steers must have certificates or registration papers in hand at time of check-in. Animals may be co-owned with siblings, or within the family farm name. If the animal is in the family farm name it must be proven that the junior exhibitor is either a son or daughter of owners of the family farm. Each junior exhibitor must be a National Junior Hereford member and the family farm or junior must be a member of the Miniature Hereford Breeders Association (MHBA) or North American Miniature Hereford Association (NAMHA) for the year 2018. Heifers and steers will be measured and weighed according to the MHBA height requirements. PLEASE make sure you check your registration papers and height requirements. Red Angus – Steers must be 50% or more Red Angus from one registered parent, be predominately red in color and display sufficient breed characteristics, which match % of registration. Heifers must be 87% or higher Red Angus. Steer & Heifer registration papers must be in hand at check in and must be in the exhibitor's name. **Foundation Red Angus Heifer Division** - Must be between 50 and 86% Red Angus and from one registered parent, be predominately red in color and display sufficient breed characteristics. Must have registration papers from the National Red Angus Association, must be in hand AND in the exhibitors name. Exhibitor must be a member in the Iowa Junior Red Angus Association.

Salers – Animals must be 50% or more Salers with either the dam or sire being registered. Both steers and heifers must have registration papers and the papers must be in the name of the junior exhibitor.

Simmental – Steers must have registration paper in hand and be ½ blood or higher. **Foundation heifers include at least ½ but not yet reaching 7/8 and Purebred heifers included 7/8 and above.** Registration papers must be in hand and in the exhibitor's name or family farm name.

Simbrah Females – 5/8 SM – 3/8 BR and must have registration paper in hand. Registration papers must be in the exhibitor's name or farm name.

Shorthorn – Heifers and Steers must be at least 15/16 and must be registered solely in the junior exhibitor's name.

ShorthornPlus – Heifers and Steers must be between 1/2 and 7/8 Shorthorn and must have appendix registration papers solely in the junior exhibitor's name.

South Devon – Heifers must be $\frac{3}{4}$ or higher and have registration papers. Steers must be registered and sired by a registered $\frac{3}{4}$ or higher bull. Papers must be in hand at check-in. Registration papers must be in the exhibitor's name.

Beef Showmanship

•All showmanship participants are eligible to compete for the

trophies within their groups – Junior (Gr. 4-6), Intermediate (Gr. 7-8), and Senior (Gr. 9-12).

•Showmanship exhibitors compete on a voluntary basis and no selection process is followed; fitting of the calf is optional. Exhibitors may win each age group of showmanship only once.

DEPARTMENT 50 BREEDING BEEF

Cow-Calf Rules

1. Exhibitors will display the calf birth date and the exhibitor number while showing.
2. Cow must have formerly been shown as a heifer or calf by the same exhibitor or immediate family member & the calf born to that cow.
3. Classes may be divided into British breed or Exotic breed and shown as two-year-old cows or as mature cows (3 years old and older). Age is based on a calendar year.
4. A minimum of four cow-calf entries are needed to divide classes.
5. To be eligible for the prospect calf class, the calf must have been born after January 1 of the current year.
6. Free standing fans will not be allowed. Hanging fans will only be allowed when attached to the tie rails or to supports attached to the tie rails. No fans will be allowed to blow from behind an animal regardless of attachment or location. All fans will blow one direction (Red Barn-face North, Green Barn-Face East)
7. Any artificial means of removing or remedying physical defects, color, or conformation in exhibiting animals such as lifting or filling under the skin (no false tail heads), adding hair or twine, and artificial filling/drenching will be considered as fraudulent deception. All animals giving evidence of such treatment will be barred from exhibition at the Marion County Fair. The decision of the official fair veterinarian, appointed by the Fair Board, is final.
8. All cattle projects including bucket calf, cow/calf, and prospect calves will be stalled at the fair.

Breeding Heifer Rules

1. All exhibitors will check-in at the scales in the Cattle Barn (see Fair Program Schedule for time) to verify birth date and tattoos, and have pedigree papers in hand. Exhibitors must be available with papers in hand to be eligible to show.
2. All Breeding Heifers (including Commercial/ Crossbred

- heifers) must have a legible tattoo.
3. Exhibitors will display the heifer birth date and the exhibitor number while showing.
4. Crossbred heifers will show in a Commercial Class. All heifers must be identified by a legible tattoo and birthday corresponding to the Livestock Identification Form, and be born during the preceding calendar year, inclusive. Any animal unable to meet the above requirements will show in crossbred class.
5. All purebred heifers must be registered and all breed requirements will follow the IJBBA classifications. Registration papers must be in the 4-H'ers name OR show a logical family relationship. Any animal unable to meet the above requirements will show in crossbred class.
6. Breeding heifer entries must be born after September 1st of two calendar years prior to current year and by December 31st of the last calendar year.
7. All heifers will be judged from the standpoint of breed characteristics: type, quality, and conformation with future usefulness as a breeding cow consideration.
8. There will be a limit of 3 heifers per exhibitor.
9. Superintendents have the discretion to combine or divide heifer classes.
10. Three registered heifers of a recognized IJBBA breed are required to add a class.
11. Free standing fans will not be allowed. Hanging fans will only be allowed when attached to the tie rails or to supports attached to the tie rails. No fans will be allowed to blow from behind an animal regardless of attachment or location. All fans will blow one direction (Red Barn-face North, Green Barn-Face East)
12. Any artificial means of removing or remedying physical defects, color, or conformation in exhibiting animals such as lifting or filling under the skin (no false tail heads), adding hair or twine, and artificial filling/drenching will be considered as fraudulent deception. All animals giving evidence of such treatment will be barred from exhibition at the Marion County Fair. The decision of the official fair veterinarian, appointed by the Fair Board, is final.

Market Heifer Rules

1. Exhibitors will display the average daily gain and the exhibitor number while showing.
2. All breeds and crossbreds will be shown together.
3. Market heifers are ineligible to show as Breeding Heifers. Only those with an average daily gain of at least 2 pounds or a minimum weight of 1000 pounds for heifers will be allowed to sell in the livestock auction.
4. Each exhibitor is limited to three market beef animals (steers and/or heifers).
5. County-raised market champion and reserve champion will be selected from those animals in the grand champion County-Raised class.
6. Grand Champion and Res. Champion Market Heifers will compete for Grand Champion and Reserve Champion Market Beef.
7. All market beef must have been born January 1-December 31, last calendar year.
8. Free standing fans will not be allowed. Hanging fans will only be allowed when attached to the tie rails or to supports attached to the tie rails. No fans will be allowed to blow from behind an animal regardless of attachment or location. All fans will blow one direction (Green Barn-Face East)
9. Any artificial means of removing or remedying physical defects, color, or conformation in exhibiting animals such as lifting or filling under the skin (no false tail heads), adding hair or twine, and artificial filling/drenching will be considered as fraudulent deception. All animals giving evidence of such treatment will be barred from exhibition at the Marion County Fair. The decision of the official fair veterinarian, appointed by the Fair Board, is final.

DEPARTMENT 54 - MARKET STEERS

Market Steer Rules

1. No floor-standing butt fans are allowed in barn exhibit area. All fans must have protective screens and safe wiring.
2. Exhibitors will display the average daily gain and the exhibitor number while showing.
3. Only those with an average daily gain of at least 2 pounds or a minimum weight of 1200 pounds for steers will be allowed to sell in the livestock auction.
4. Each exhibitor is limited to a maximum of three market beef

animals (steers and/or heifers).

5. Three steers of any recognized breed are required to add a class. Refer to the Iowa Junior Beef Breeds Council Guidelines for specific breed requirements.
6. All slick sheared steers must, prior to arrival at weigh-in at the fair, be clipped to no more than ¼" of hair on any part of the body, except the tail switch, (the tail switch being no more than 10" above the end of the cartilage of the tail) which may be ratted and balled or may be bobbed off. Steers will be checked for hair length at weigh-in and if found in violation of this rule will be automatically moved to the fitted class.
7. First and second place winners in each individual market class are eligible to compete for Breed Champions and Reserve Breed Champions.
8. All calves will be placed on individual merit, from market standpoint, taking into consideration weight for age, conformation, quality, finish, and breed type.
9. All calves must be stabled in the barn or place designated by Superintendent.
10. Market Steers shall be shown by weight and not by age.
11. All crossbred calves will show in a Crossbred class. There will be a Lightweight, a Mediumweight, and a Heavyweight division.
12. Market Steer classes will be designated by Superintendents for benefit of exhibitors.
13. At the beginning of the Market Steer show, the top ten rate-of-gain market beef animals will be shown in the Rate-of-Gain class.
14. All registered steers must have legible tattoos. Steers without legible tattoos will show in a crossbred class. Registration papers must be in the 4-H'ers name OR show a logical family relationship. Member must have papers in hand at check-in.
15. All beef must be born between January 1 and December 31 of last calendar year.
16. County-Raised Market champion and Reserve Champion will be selected from those animals in the grand champion market class.
17. The top five animals will be recognized in the grand champion market class.
18. Free standing fans will not be allowed. Hanging fans will only be allowed when attached to the tie rails or to supports attached to the tie rails. No fans will be allowed to blow from behind an animal regardless of attachment or location. All fans will blow one direction (Green Barn-Face East)
19. Any artificial means of removing or remedying physical defects, color, or conformation in exhibiting animals such as lifting or filling under the skin (no false tail heads), adding hair or twine, and artificial filling/drenching will be considered as fraudulent deception. All animals giving evidence of such treatment will be barred from exhibition at the Marion County Fair. The decision of the official fair veterinarian, appointed by the Fair Board, is final.

Dog Rules

Dogs will be judged on response to commands and general overall behavior as set forth in training given to members in this project.
To exhibit in the Marion County 4-H Dog Department, a member must:

1. Observe the usual requirement of 4-H projects, such as enrollment, completed livestock identification on file with Extension Office, completing record sheets, etc.
2. Must be current on Rabies & Parvo vaccinations
3. are for, train, and handle the dog.
4. Dogs must be on leash and collar and not enter any other

livestock buildings.

5. Attend at least six of the regularly scheduled training sessions before he/she is eligible to show at the County Fair.
6. The dog must be a minimum age of 6 months as of May 1 of current year.
7. Females in season cannot be shown.
8. Dog Exhibitors are responsible for cleaning up after their dog while on the fairgrounds.
9. Dogs are to return home after the show.
10. Exhibitors must be a 3rd year trainer before they can train a second dog.
11. Dogs must be exhibited in an obedience class to show in agility.
12. Dogs and handlers who score 90% in a class must move to the next class the following year.
13. Superintendents have final call on class placements.

Dog Classes

OBEDIENCE

Class 101 – PRE-NOVICE A – This class is ONLY for dogs and exhibitors in their first year of training. Dogs will heel on leash, figure 8 on leash, stand for examination on leash, recall on leash, and do long sits for one minute and down for three minutes on leash. Dogs must not have completed any leg toward any CD degree.

Class 102 – BEGINNER NOVICE – 2ND+ year exhibitor/2nd year dog OR either exhibitor or dog with previous training experience but 1st year for the other team member. Exhibitor/dog team may enter this class until exhibitor has received a qualifying score. Dog must not have earned any obedience title. Dog must not have earned any obedience title. Heel on leash, Figure 8 on leash, Sit for examination on leash, Recall (no finish) OFF leash, sit/stay handler walks ring.

Class 103 – PREFERRED NOVICE – 3RD+ year exhibitor. Exhibitor/dog team may enter this class until exhibitor has received a qualifying score. Dog must not have earned any leg towards any CD obedience title. Dogs will Heel & Figure 8 on leash, Stand for examination OFF leash, Heel free OFF leash, Recall with finish OFF leash, Down/Sit Handler walks ring drop leash.

Class 104 – NOVICE - For exhibitors who have achieved a qualifying score in Preferred Novice at any 4-H show. Dog may not have earned third leg towards any CD title. Dogs will Heel & Figure 8 on leash, Stand for examination OFF leash, Heel free OFF leash, Recall with finish OFF leash, Long sit (1 min) drop leash, Long down (3 min) drop leash.

Class 105 – GRADUATE NOVICE – Exhibitor/Dog team may enter this class until exhibitor has received a qualifying score. Exhibitor must provide their own dumbbell for this class. Dog must not have earned any leg towards and CDX title. Dog will Heel free & Figure 8 OFF leash, Drop on Recall OFF leash, Dumbbell recall OFF leash, Dumbbell recall over high jump OFF leash, Sit/Down (3 min) handler out of sight drop leash.

Class 106 – PREFERRED OPEN – No limit on number of years exhibitor/dog team may enter. Exhibitor must provide their own dumbbell for this class. Dog must not have earned their 3rd leg towards and CDX title. Heel free & Figure 8 OFF leash, Drop and recall OFF leash, Retrieve of Flat OFF leash, Retrieve over high jump OFF leash, Broad Jump handler at side OFF leash.

AGILITY

This is an obstacle course designed to test the agility of the dog and the handler's ability to guide their dogs correctly through each obstacle. The only restriction is that the dog is not physically forced to do any one object. A dog is given 3 refusals before being asked to move on. The handler and dog with the shortest time and the most correctly completed obstacles will be the winner.

Class 201 – PRE-NOVICE AGILITY - For dogs and exhibitors in their first year of dog training. Dogs will follow a course on leash. Time standard will be based on two minutes. Penalties will be assessed for any time over. This class is open to exhibitors showing in Pre-Novice A.

Class 202 – NOVICE AGILITY - For exhibitors in their second year or greater and dogs who are in their first to third year of training. Dogs will follow a course on or off leash. 1. Exhibitors must check in with Superintendents in horse barn, between 6:00 p.m. Friday and 10:00 a.m. Saturday. Class entries will be verified at that time.
2. All animals are to be vaccinated for influenza (flu) and Encephalomyelitis (WEE, EEE). Exhibitors will deliver a Health Care Statement to certify the vaccinations along with

their county fair entry form due July 1. Superintendents also strongly encourage vaccinations for strangles and rhinopneumonitis. Please check with your veterinarian.

3. Each exhibitor may show not more than 2 animals (mare & nursing foal will be considered as 1 animal). Mares & foals will NOT be stalled during the Fair unless showing in a performance class. Mares & foals will arrive and return home the day of the show. An adult may assist an exhibitor showing a mare and foal.
4. Ages in the halter classes are determined on January 1 of the year foaled.
5. Members are to enter project in proper class by the entry deadline.
6. Superintendents have discretion to combine or divide classes.
7. Aged animals may show in only one halter class.
8. No stallions may be shown in any class except the foal classes.
9. All under 57 inches will show as ponies.
10. Ponies will be measured at the discretion of the Superintendents.
11. Previous Showmanship winners will be ineligible to compete in their respective age groups.
12. All exhibitors will wear BLUE JEANS and a solid, plain, long-sleeved shirt with a collar of any color including white. If showing English, English attire is encouraged. These rules apply any time exhibitor is on horseback with the exception of speed events. Exhibitors will be allowed to wear a 4-H or FFA t-shirt during speed events.
13. Safety helmets are required for all youth when mounted or driving. ASTM/SEI certified helmets with chin strap and properly-fitted harness are used every time, every ride.
14. All tack, equipment, and show guidelines are contained in the Guide for 4-H Equine Shows in Iowa (available from the Extension Office).
15. Only exhibitors and their immediate families may ride horse/pony/mule on the fairgrounds. No more than one rider per horse. No Riding Without Proper Equipment/ Tack. NO RIDING IN BARNS * NO TACK STALLS * EXERCISE IN ARENA/ROUND PEN ONLY * NO RIDING IN ARENA AFTER 10:00 p.m.

Rabbit Showmanship & Herdsmanship

Exhibitors competing in showmanship must show their own projects. Previous winners of rabbit showmanship awards are not eligible to compete again in their age groups.

Showmanship will be divided into Three classes: Junior (grades 4-6), Intermediate (grades 7-8), and Senior (grades 9-12).

Rabbit Rules

1. Rabbit exhibitors must check in their rabbits with superintendents to be eligible to show. Check-in time is 8:30-9:30 Saturday morning.
2. All rabbits must be free from communicable disease and pass health standards. Any rabbit unhealthy or in unthrifty condition may be refused pen room. In case of arbitration, decision of appointed veterinarian shall be final.
3. All rabbits must be permanently earmarked by tattoo (no ink pens) in rabbit's left ear so there will be no question as to owner of the rabbits. Standard of perfection available in 4-H Rabbit Guide; more details on project available from project leader and Extension Office. If problem arises, decision of superintendent and Extension Staff is final.

4. All rabbits must be in exhibitor's possession and tattooed (except fryers and meat pens) by May 1.
5. An exhibitor is limited to six rabbits, except fryers/meat pen. An exhibitor is allowed two entries per class, except fryers. Each exhibitor may enter one meat pen and three single fryers. Entries must be within the age and weight limits for the class.
6. Superintendent may adjust classes according to entry numbers.
7. Top two meat pens may be sold at livestock auction (sign-up deadline is 4:30 p.m. Tuesday).
8. Rabbits will be judged on how close they come to standard of perfection. Point total if needed. Only sexually intact rabbits are eligible for show.
9. All varieties within a breed will be judged in the same class. Proof for Breed, such as papers, pedigrees, records, etc. may be requested. All rabbit entries must be listed with breed of rabbit on entry. Breed types are listed in 4-H Rabbit Book, ARBA Rabbit Guide, etc. If in doubt, talk to superintendents.
10. Best of Show will be picked from Best Six Class, Best Four Class, and Best Other Breeds.

Showmanship

Exhibitors competing in showmanship must show their own project. Previous winners of sheep showmanship awards are not eligible to compete again in the age groups they won.

Showmanship will be divided into three classes: Senior Showmanship, Grades 9-12; Junior Showmanship, Grades 4-8; First-Year-Member Showmanship, 13-years-old and under on day of show.

Sheep Rules

1. All commercial ewe lambs must be weighed-in and tagged at the official weigh-in in May. Commercial ewe lamb and market lamb classes will be divided and shown by weight.
2. No muzzles, drenching, or painting of lambs allowed. Violators are subject to disqualification.
3. Market lambs weighing less than 85 pounds are not eligible to show or sell in the sale.
4. All sheep in place by 7:00 a.m. Saturday. Members must be present at their pen, to check in their sheep. Once the exhibitor is checked in, then they will be released to go across the scale.
5. All sexually intact sheep (ewes & ewe lambs) exhibited at County Fair, must have an individual Scrapie Flock of Origin identification tag.
6. Sheep MUST be slick sheered within 1 week of weigh-in and will be observed for overall health. Sheep exhibiting signs of club lamb fungus and/or other contagious disease(s) will be disqualified and ineligible for show and need to be removed from the premises.
7. We strongly recommend the use of wood shavings/sawdust for bedding of pens.
8. Substitute exhibitors (helpers) must be Marion County 4-H or FFA members of eligible age (see #6 of General Rules).
9. Members should not bring prolapsed animals to the fair. Animals exhibiting evidence of prolapse while on display at the fair may be subject to disqualification and market lambs may not be eligible for sale in the auction. If your animal is exhibiting signs of prolapse, consult your veterinarian

Bottle Lamb and Kid Rules

1. Will be shown on Monday @ 2 p.m.
2. Interviews will take place starting at 11 a.m. on Monday
3. The project is open to 4-H & FFA members of all ages enrolled in a goat or sheep project. Lambs and kids must be bucket or bottle-fed, no nursing is permitted.
4. Lambs and kids may be dairy, meat, or wool/hair varieties, crossbred or straightbred, either sex but must be: a) born after Jan. 1 and b) identified by a tag or tattoo; all sexually intact goats and sheep must have an individual Scrapie Flock of Origin identification tag c) project animal must be in the exhibitors care by May 1.
5. An exhibitor may identify up to 3 animals but will only show 1 at the fair. Animals are to be brought in, shown, and returned home on show day. Lambs and kids shown in these classes MAY NOT be shown in other classes.
6. Classes will be divided into two exhibitor age groups - (a) Grades 4-6 and (b) Grades 7-10 and further classification at the discretion of the superintendent.
7. Lambs and kids may be shown at halter
Judging will be on what the individual has learned about care, feeding, grooming and showing of lambs or goats, and the general health and confirmation of the animal and the completed record sheet. Judging will be based 60% on interview and 40% on show ring.

Breeding Sheep Rules

1. All Yearling ewes must have been born in the previous calendar year. All ewe lambs must have been born in the current calendar year.
2. 4-H'ers/FFA members may have the assistance of a 4-H'er/FFA member who meets fair age eligibility requirements in the yearling ewe class. The assistant's help will be limited to helping set hind legs.
3. Breeding lambs are not eligible to show in market lamb classes.
4. In purebred classes, any name will be accepted as the owner on registration papers as long as evidence can be shown that the exhibitor holds ownership or some degree of ownership in

the animal and the exhibitor has logical relationship to the name of the owner of the registration paper.

5. If not registered, sheep will be shown in the Commercial class.
6. Ewe lambs or yearling ewes shown in a breeding class are NOT eligible for livestock sale at County Fair.
7. Superintendents may also reassign breeding sheep to a different class, based on the entry's eligibility. For example, speckled faced ewe classes are designed for entries showing evidence of cross breeding.

1. All lambs must be have been born after January 1 of current year and weighed in at official weigh-in in May.
2. A Speckle-Face Market Individual class may be determined at weigh-in. Speckle-face lambs must have speckles on TWO of three areas: face, ears, and legs. Decision by superintendents is final.
3. All lambs should weigh 90 lbs. or more. Lambs weighing less than 85 lbs. are not eligible to show or sell.
4. An exhibitor may enter no more than six (6) market lambs (ewes and wethers).
5. No more than two entries may be shown in any one class by the same exhibitor.
6. An exhibitor may show only 1 pen-of-three.

7. Individuals and pens-of-three will be divided by weight into classes at the discretion of the Superintendents.
8. All lambs shown in the market lamb classes must be slick sheared within 1 week or less of weigh-in at fair.
9. Exhibitors are expected to care for their lambs in an acceptable manner. No icing of lambs allowed. Any abusive care, including slapping or excessive modification of lambs will be grounds for disqualification at the discretion of show officials. All lambs must have four feet on the floor in the show ring at all times. Exhibitors will receive one warning if they are found lifting or slapping lambs. Second offenses will result in exhibitor disqualification from the show.
10. Sheep will be observed at weigh-in and entry check-in for overall health. Therefore, no blankets or other coverings will be permitted on lambs at weigh-in. Sheep exhibiting signs of club lamb fungus and/or other contagious disease(s) will be disqualified and ineligible for show and need to be removed from the premises.
11. To be eligible to show, Market lambs must not have evidence of intact testicles at fair time.

Showmanship classes are voluntary for all exhibitors except previous winners of each age group. Previous winners of swine showmanship awards are not eligible to compete again in their age groups.

Exhibitors must show their own project. Showmanship will be divided into three classes: Senior, Grades 9-12; Intermediate, Grades 7-8; Junior, Grades 4-6

Swine Rules

1. All pigs must be in place by 8:00 p.m. Friday, with ear notch check-in following.
2. Weigh-in will be Saturday at 9:00 a.m.
3. No wet hogs at weigh-in. No re-weighs.
4. Green class sheet must be turned into the VIP room (Extension) by 4:00 p.m. Saturday.
5. All non-sale pigs MUST be removed from the barn on Wednesday evening after 8 p.m.
6. A maximum of 12 pigs may be identified (Universal ear-notch system) on the LS-106 form by May 1 of the current year. Pigs will be checked at weigh-in for proper identification.
7. All exhibitors must have YQCA Certification and Premise ID number on file with their LS-106 ID forms at the Extension Office
8. No pseudorabies (PRV) testing is required for county fair. Vaccination for PRV and erysipelas is recommended. All pigs returning home are subject to rule # 6 of the Health Requirements.
9. Entries are open to straight-bred or crossbred pigs, either bar rows or gilts for market, farrowed after January 1, of the current year, and notched by the Universal Ear Notching System. Those not properly ear-notched will not be eligible for exhibit.
10. For all purebred market and breeding swine: Registration papers must be in the 4-H'ers name OR show a logical family relationship. Member must have papers in hand at check-in. Litter registrations will be accepted. All purebred pigs must meet the breed registry requirements.
11. There shall be no coloring agents, powder or oil used on hogs. The use of either is strictly prohibited. Pigs in violation will not be allowed to show.
12. Due to packer demands and concerns, the pigs hair shall not be shorter than ½ inch.
13. Minimum weight at the Fair weigh-in for all pigs is 230 lbs and maximum is 310 lbs. Pigs not meeting weight requirements may only be shown in the Non-qualifier Class (see class requirements Rule 13).
14. **Non-Qualifier Class:**
Member is only eligible to show in this class if none of the

pigs brought are within the market weight limits.
Receive participation ribbon only and not eligible for premiums. Not eligible for the sale. Must be taken home after the show.

*Exhibitor may also exhibit in showmanship

15. The Breeding Gilt may show in the Breeding Gilt class AND in a Pen-of-Three. She may NOT, however, show as a Market Individual.
16. Each exhibitor may show 2 pigs in the individual classes and may also use these in the Pen-of-Three class.
17. A maximum of 4 pigs may be shown (2 individuals, 3 pigs in a Pen-of-Three, 1 Commercial Gilt, & 1 PB Gilt). Under no circumstances will one exhibitor be allowed to exhibit more than 4 pigs. This means NO extra pigs.
18. Individuals, Pens of Three, and Breeding Gilts will be weighed and divided into classes as designated by superintendents.
19. All entries must designate total number of pigs to expedite penning.
20. No clean-up of pens until all animals are loaded out

Herdsmanship duties are the responsibility of the exhibitors with help as needed. Exhibitors are also expected to be courteous and follow general fair rules. Good attitudes also have a bearing on the score.

Special recognition is offered to the clubs or chapters making the best showing during the full period of the Marion County Fair.

A Herdsmanship winner will be chosen in each species/barn and also an overall winner (club/chapter must have exhibits in more than half of the barns to be eligible) will be named. Judging will be based on a point system which includes the following:

1. Cleanliness of Pens and Storage Areas 25 pts.
 - a. Bedding adequate, dry, clean, and in place
 - b. Manure hauled out and deposited in proper place
 - c. Animals securely tied and/or penned
2. Appearance of Exhibits 25 pts.
 - a. Exhibits lined up in attractive manner
 - b. Hay & straw neat and orderly

- c. Feed boxes, brooms, forks, scoops, etc. stored properly
 - 3. Stall/Pen Decorations 25 pts.
 - a. Decorations clearly define an exhibitor's space
 - b. Herdsmanship Signs from previous winners displayed
 - c. Stall cards readable from alley, neatly arranged, clean, and complete
 - 4. Exhibitor's Contribution 25 pts.
 - a. Exhibitor doing his/her own work
 - b. Friendly, polite, and courteous to others
 - c. Exhibitor present to oversee the general care of animals
- Total: 100 pts.

A committee will judge the club exhibits, in each barn daily. The winners will be posted and recognition given at the annual awards ceremony. **ALL STALLS MUST BE CLEANED BY 6:00 Thursday!** This includes removal of ALL decorations and stall cards.

LIVESTOCK JUDGING CONTEST

DEPARTMENT 66

1. Open to any 4-H and/or FFA member, except members with college training. Also, an open adult division allows adults to participate.
2. There will be classes of livestock for numerical placing, and question classes.
3. Awards will be presented to the top individuals and top teams.
4. The top four 4-H individuals (has completed at least 9th grade and two years of club work) will make up the 4-H State Fair judging team.

SHOWING CODE OF ETHICS

As developed by the INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS

Exhibitors of animals at livestock shows shall at all times deport them-

selves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of Ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's

performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation, and respect. No person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to

- disciplinary action.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
 10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
 11. The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
