PROPOSITION B

SHALL THE NUMBER OF LIBRARY BOARD OF TRUSTEES BE REDUCED FROM SEVEN (7) MEMBERS TO FIVE (5) MEMBERS AND SHALL THE TERMS OF OFFICE BE REDUCED FROM SIX (6) YEARS TO THREE (3) YEARS BY AMENDING TITLE V, CHAPTER 1, SECTIONS 5-1-2 AND 5-1-4(1) TO READ AS FOLLOWS?

5-1-2 LIBRARY TRUSTEES: The Board of Trustees of the Scranton Public Library, hereinafter referred to as the Board, consists of five (5) members. The Mayor shall appoint all board members, subject to the approval of the City Council. (Code of Iowa, Sec. 392.5)

5-1-4(1) TERMS OF OFFICE: All appointments to the Board shall be for three (3) years, except to fill vacancies. Each term shall commence on July 1st. One-third of the total number of Board members, or as near as possible, shall be appointed every year for the purpose of staggering terms. (Code of Iowa, Sec. 392.5)
