- **How to Enter**
- 1. FILL OUT THE FORM; INCOMPLETE ENTRY FORMS WILL NOT BE PROCESSED.
- 2. INCLUDE ALL SIGNATURES FOR team members. Parent or guardian signatures are required if player (s) are under 18 years of age. Teams will not be registered without these signatures.
- 3. MAIL YOUR COMPLETE ENTRY FORM, and entry fee to the address listed below.
- 4. Your team captain will receive written verification along with more information about the tournament and other events.
- **Costs**
- A non-refundable entry fee of \$15.00 a player must accompany your entry form
- **Registration**
- Pre-registration is not required, but appreciated.
- **Team Check-In**

Team check-in is 12:00 p.m. at the court in Russell Park. All players are required to attend the check-in. Here, you will receive your team schedule. In case of inclement weather, games will be played at the Greene County Community Center or Greene County Middle School

- **Important Rules**
- 1. Each team will consist of three or four players: three starters and one substitute.
- 2. If able, teams will be grouped in divisions with other teams of similar average age, size, and playing ability.
- 3. All teams are guaranteed at least two scheduled games.
- 4. Games will be played on half a court, using Official round ball Rules.
- 5. Scoring: one point per basket; two points for shots made over 20 feet. First team to 15 points, up by at least two, wins. Possession alternates after each basket.
- 6. We reserve the right to verify any player's age, size or playing experience. Inaccurate information is grounds for disqualification of the entire team. Each player is encouraged to carry personal identification.
- 7. We reserve the right to reduce the number of scheduled games, or shorten games, due to unforeseen circumstances.
