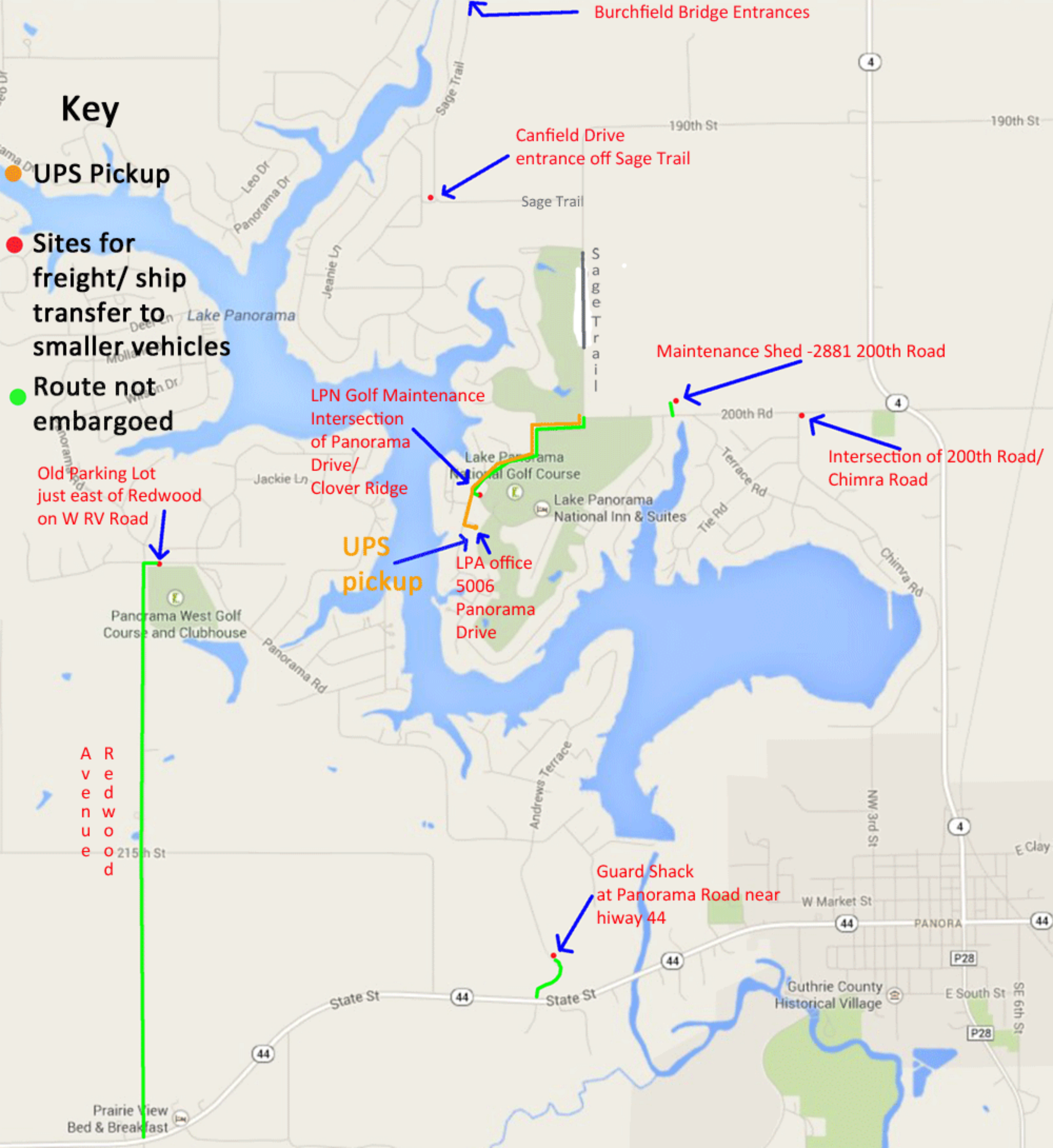

# Road Embargo

## Delivery Alternatives

- All vehicles 5 tons and over are prohibited from LPA seal coat streets.
- All UPS packages will be delivered to LPA office.
- Other deliveries may be transferred to vehicles under 5 tons at points designated on map on next page. Total vehicle weight should not exceed 5 tons (10,000 pounds.)
- The green routes on the map are mostly deep asphalt and not subject to the embargo. Vehicles over 5 tons are allowed on these portions of LPA streets ONLY.
  - This includes from the intersection of Sage Trail and 200<sup>th</sup> Road on Panorama Drive to the LPA office (including going past the LPN maintenance shed.)
  - Also included is the stretch of Panorama Road from Highway 44 to the Guard Shack parking area.
  - The short stretch from Redwood Avenue (county road) on West RV Road to the parking lot a few hundred feet east on the south side of the road.
  - Other locations for freight or delivery transfers are noted on the map.

## Notice to members expecting deliveries by United Parcel Service (UPS)\* during the LPA Road Embargo—

- All UPS deliveries for LPA members will go to the LPA office at 5006 Panorama Drive.
- The LPA office staff will notify members by phone or email (if the LPA has that contact information) that their delivery has arrived.
- If the LPA does not have your contact information, and you are expecting packages via UPS, please contact the office.
- Normal LPA office hours are 8 a.m. to 4:30 p.m. To pick up packages at other times, please call the LPA office (641) 755-2301 to make arrangements. We will try to coordinate pick-ups during non-office hours, if necessary.
- If the person to whom the package was shipped can't pick up the package personally, please notify the office of the individual(s) authorized to pick up the package(s).
- Personal identification may be required for package pick-up.
- An alternative pick-up location may be established for exceptional circumstances.

\*UPS service trucks exceed the load limit. Small delivery vans by other companies are usually under the load limit. Larger deliveries will have to make arrangements for distribution at approved locations.
