On February 5, 2019 at approximately 2006 hours, I was dispatched to a vehicle collision in the 1400 block of Evelyn Street.

Vehicle 1 was a 2011 Gray Chrysler Town and Country driven by Laura Pieper.

Vehicle 2 was a 2003 Green Ford Explorer driven by Marisol Iglesias De Garcia.

Both vehicle were traveling eastbound on Evelyn Street. Vehicle 2 slowed down to turn into her driveway at 1416 Evelyn Street. Vehicle 1 attempted to slow down but due to the snow on the ground, was not able to slow down and lost traction, resulting in the vehicle to slide. Vehicle 1 attempted to turn the vehicle into the grass but was unable too.

Vehicle 2 was struck on the rear driver side by the front passenger side of Vehicle 1. Vehicle 1 had approximately \$4000 in damage and was later driven away. Vehicle 2 had approximately \$8000 in damage and was left in the drive way of the residence.

The driver of Vehicle 2 was examined by EMS due to airbag deployment and complaints of hip pain, however she declined medical treatment. Due to contributing weather conditions, no citations were issued.
