UNIT ONE, OPERATED BY CHARLES SMITH WAS TRAVELING SB ON 18TH ST AND STOPPED AT THE INTERSECTION OF WILLIS AVE. ANOTHER UNINVOLVED CAR WAS IN THE TURNING LANE ON 18TH ST AT THE INTERSECTION ALONG WITH UNIT ONE. UNIT TWO WAS TRAVELING EB ON WILLIS AVE APPROACHING 18TH STREET. IT APPEARED THAT THE UNINVOLVED CAR BEGAN TO TURN WB ONTO WILLIS AVE AT THE SAME TIME THAT UNIT ONE STARTED INTO THE INTERSECTION TRAVELING SB. UNIT ONE THEN STRUCK UNIT TWO ON THE DRIVER'S SIDE BROADSIDE, CAUSING UNIT TWO TO SPIN AROUND 360 DEGREES FACING WB ON WILLIS IN THE MIDDLE OF THE STREET. UNIT ONE ENDED UP FACING EB ON WILLIS BETWEEN THE CURB AND UNIT TWO ON THE SOUTH SIDE OF WILLIS AVE. UNIT ONE DAMAGE WAS ESTIMATED AT \$5000. UNIT TWO DAMAGE WAS ESTIMATED AT \$4000. THE DRIVER OF UNIT ONE WAS CITED FOR FAILURE TO OBEY STOP SIGN. NO INJURIES WERE REPORTED.
