### Description of the activities.

- Raccoon Valley Radio had one paid internship (part-time) from December 12, 2024 to January 9, 2025. This individual assisted with production, on-air operations, as well as traffic and billing.
- January 29, 2025, John McGee presented to the Journalism Class at Adel-Desoto-Minburn. We discussed careers in radio, as well as standards in new coverage and journalism. 15 Students and a teacher present.
- January 31, 2025: At our EOM Managers meeting today, management discussed the upcoming EEO Audits that will be happening with several Iowa Radio Stations. We also discussed our current EEO System that includes, Recruitment, Record Keeping and Reporting. After talking about our current plan, it was decided that our current system is working and has helped with our recruiting and hiring of staff. It has also helped with wide dissemination of jobs openings. It was also discussed how we can take part in more job fairs to improve our outreach. Company SEU's will further look into upcoming job fairs to help increase participation.
- February 12, 2025 Mailed Applications for Business and Broadcast Scholarships to 10 area high school counselors. Schools included Perry, Greene County, Paton-Churdan, Woodward Granger, A-D-M, West Central Valley, Adair Casey/Guthrie Center, Panorama, Nodaway Valley, Winterset. We ran 30 second announcements promoting our Broadcasting Scholarships.
- March 29, 2025, Raccoon Valley Radio participated in a S.T.E.M, event at Guthrie Elementary School. We set up a booth and educated students and parents about the careers in Broadcasting, specifically those that a line with Science, Technology, Engineering and Math
- April 11, 2025, Shi-Quan Nettingham, did 4 career day presentations at Adel-Desoto-Minburn High School. He highlighted his collegiate degrees, job responsibilities, and provided some samples of the news and sports stories. Students asked questions about the radio industry and daily tasks.
- April 23, 2025, John McGee, GM and Doug Rieder, Sports Director attend a Career Fair at Greene County High School. We meet with three different groups of students totally 75 students and coverage all the various careers and radio and answered questions about the broadcasting industry.
- May 13, 2025 Awarded 2 Business and Broadcasting Scholarships. Applications were mailed to 10 area high schools in February and applications were also available online at raccoonvalleyradio.com with on air promotional announcements airing February 1 April 15, 2025. We received 18 applications.
- June 4, 2025: Participated in a Job Fair sponsored by Iowa Workforce Development. The Job Fair took place at the Marion County Public Health Building at 2003 North Lincoln In Knoxville. The Job fair was in conjunction

- with the Iowa Works Mobile Workforce Center. We visited with job seekers about opportunities at our stations. Most conversations centered around Advertising Sales and On-Air positions. Several job seekers took applications to fill out and return to the radio station for further review and possible interviews. Participating for our Company was SEU Jim Butler
- June 2025-August 2025 4-H Recording: Prior to each County Fair for Adair,
  Dallas, Greene, and Guthrie Counties, we reached out to the local 4-H clubs and
  recorded local 4-H participants to inform the public about their 4-H projects.
  Participants learned about recording digital audio and how to edit and produce
  commercials and other station promotional announcements.
- August 13, 2025, John McGee, GM, Owner, Presented to the Perry Rotary. Discussed the future of local radio and how, as an owner, we plan to continue to serve our community.
