Official Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

a. The "SUMMER CONCERT CONNECTION" contest (the "Contest") will begin on Wednesday September 19, 2018 at 7:00AM Eastern Time ("ET") and end Wednesday September 26, 2018 at 1:00 PM ET (the "Contest Period").

Tune into Blazer 91.1 WVUB HD (the "Station") during the Contest Period for the on air host to play the 'Summer Concert Connection' sounder to be played during the hours of 12:00 a.m.-11:59 p.m. during the contest period. Upon hearing the sounder, listeners may call the station at 812-888-4337. (Standard message rights might apply). To enter the contest, the listener must call the station. Multiple times per day during the contest period, the on-air host will randomly paly the sounder to call into the station. The ninth caller will be asked to choose one (1) or two (2) to randomly choose the contents of the grand prize pack.

b. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.

c. For those listening to the Station stream on the Internet: Please be advised that you may be listening to a delayed stream of the radio signal, which may vary depending on your computer's memory capacity and your connection. For that reason, we strongly recommend that you tune your radio to the Station to participate in this or any other call-in contest to be sure you are participating in "real time." The Station assumes no responsibility for contestants not making timely phone calls to the station as a result of the delays in the Internet stream.

d. There is no limit to the number of times a listener may attempt to call or qualify, but a listener may only win once every thirty (30) days from any contesting from the Blazer of a grand prize with and (ARV \$100+).

2. ELIGIBILITY RESTRICTIONS

a. The contest is open to all persons who reside within the Over the Air coverage area of WVUB-FM. Employees of the Station, its licensee, and affiliates, its advertising and underwriting agencies, participating sponsors/promotional partners, other radio stations in the Evansville metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

b. Only one winner per household is permitted in this contest. A listener may not win this contest if a member of his/her family or household has won this Station contest within 30 days of a grand prize (ARV \$100+).

3. PRIZE

a. Ten (10) Grand Prize Packs will be awarded in this contest. An unlimited amount of qualifiers will be taken for this contest. The prize will be awarded in no particular order to qualifying contestants. The winner will be chosen by a random at 12:30 p.m. on each Friday during the contest period. There will be one grand prize pack awarded each week. The ARV will vary. (ARV \$58 for BORNS tickets, \$59 for Revivalists) The events will be held at Garfield Park in Indianapolis, IN. The dates and times are listed on the tickets, September 27, 2018 and September 28, 2018.

b. The grand prize packs will need to be picked up at the Blazer business offices located at 1200 North 2nd Street, Davis Hall, Vincennes University, Vincennes, IN 47591 between the hours of 8:30 a.m. and 4:30 p.m. EST. In the case of physical tickets, rather than will call tickets, WVUB will mail the tickets to the winner at the mailing address they provide. However, the winner must send an email with a verifiable address and request the prize be sent in writing. WVUB-FM will not be responsible for prizes that are lost in the mail or delivered late or to the wrong address.

c. There is no substitution, transfer, or cash equivalent for prizes, except that station may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

d. Unless otherwise stated, all prizes must be claimed in person at the Station at the address identified above during regular business hours and within ten (10) business days of winning, excluding holidays and/or close of business on September 26, 2018. After such time, ownership of said prize reverts back to the Station to be disposed of at its discretion. The winner then loses all claims and rights to said prize. Proper identification must be presented by any winner to claim prize. As a condition to receiving the prize, any potential winner must be willing to complete and sign a Winner's Affidavit and Release, releasing the Station from all liability in connection with winner's participation in the contest and acceptance, use, or non-use of the prize. d. Winner needs to listen to Station to win. Winner must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited.
