Official Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

- 1. HOW TO ENTER
- a. The "WICKED ON BRAODWAY TICKETS" contest (the "Contest") will begin on Monday March 26th, 2018 at 7:00AM Eastern Time ("ET") and end Friday April 13th, 2018 at 11:00 AM ET (the "Contest Period").

Tune into Blazer 91.1 WVUB HD (the "Station") during the Contest Period for the on air host to play the 'wicked ticket sounder' to be played during the hours of 7:00 a.m.-1:00 p.m. during the contest period. The on-air host will take the first three callers and gather their name, phone number and address. The first three callers will be entered into the grand prize drawing each time the sounder is played during the mentioned hours of the contest period.

- b. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.
- c. For those listening to the Station stream on the Internet: Please be advised that you may be listening to a delayed stream of the radio signal, which may vary depending on your computer's memory capacity and your connection. For that reason, we strongly recommend that you tune your radio to the Station to participate in this or any other call-in contest to be sure you are participating in "real time." The Station assumes no responsibility for contestants not making timely phone calls to the station as a result of the delays in the Internet stream.
- d. There is no limit to the number of times a listener may attempt to call or qualify, but a listener may only win once every thirty (30) days from any contesting from the Blazer of a grand prize with and (ARV \$100+).

2. ELIGIBILITY RESTRICTIONS

a. The contest is open to all persons who reside within the Over the Air coverage area of WVUB-FM. Employees of the Station, its licensee, and affiliates, its advertising and underwriting agencies,

participating sponsors/promotional partners, other radio stations in the Evansville metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

b. Only one winner per household is permitted in this contest. A listener may not win this contest if a member of his/her family or household has won this Station contest within 30 days of a grand prize (ARV \$100+).

3. PRIZE

- a. One hundred eighty (180) qualifiers will be taken for this contest. The prize will be awarded in no particular order to qualifying contestants. The winner will be chosen by a random drawing of the one hundred eighty (180) qualifiers. One qualifier will receive the Grand Prize Pack (ARV of \$263 each ticket \$131.50) including two tickets to see Wicked. The event will be held at the Old National Centre (Murat theater) on Sunday May 13th, at 1:00 pm ET 2018 in Indianapolis.
- b. The grand prize pack will need to be picked up at the Blazer business offices located at 1200 North 2nd Street, Davis Hall, Vincennes University, Vincennes, IN 47591 between the hours of 8:30 a.m. and 4:30 p.m. EST. In the case of physical tickets, rather than will call tickets, WVUB will mail the tickets to the winner at the mailing address they provide. However, the winner must send an email with a verifiable address and request the prize be sent in writing. WVUB-FM will not be responsible for prizes that are lost in the mail or delivered late or to the wrong address.
