#### **Official Contest Rules**

The form is also available at wvub.org Information from the form will not be sold to any other parties.. Listeners may enter as many times as they wish. The winner will be notified by the station via phone call from the number from which they texted to receive a prize pack.

For those listening to the Station stream on the Internet: Please be advised that you may be listening to a delayed stream of the radio signal, which may vary depending on your computer's memory capacity and your connection.
