OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

HOW TO ENTER

a. These rules govern the Ticket Giveaway (the "Promotion"), which is being conducted by WVUB-FM. The Promotion begins on *Thursday, November 21, 2024*, and ends on *Wednesday, November 27, 2024*.

b. To enter the Promotion, listeners must comment with an emoji and share the original post from the Blazer Facebook to enter for a chance to win <u>two (2) tickets</u> to the <u>Nitro Circus</u> <u>event</u> at the <u>Fishers Event Center in Fishers, Indiana, on December 1, 2024.</u> The contest runs <u>Monday, November 25, 2024, at 1:00 p.m. ET</u> and ends <u>Wednesday, November 27, 2024, at 8:00 a.m. ET</u>.

The Promotion will be carried out via Facebook. Contestants should like and share the original post from the Blazer Facebook page. Only one entry per person. By sharing the post, contestants give the station the right to repost it, at their discretion, on the station website WVUB.org, or any other station-operated media properties, including all social media platforms.

Vincennes University Broadcasting WVUB-FM (the "Station") will in no way be liable or responsible for the failure of any phone, other calling instrument, computer, or other device or connection, no matter the reason for the person's inability to complete the registration process.

c. The Station will award <u>2 prizes</u> at random based on the number of entries received prior to the deadline. If there are an insufficient number of entries (*less than 1*), the prizes will revert back to the station.

ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all persons who are **18 years of age or older** and who reside in the geographic listening area of the station. Employees of Vincennes University Broadcasting, the Station, the Station's Underwriting Agent (collectively, "Promotional Entities"), their respective parent, subsidiary, and affiliated entities, Station's advertising and promotional agencies, and

participating sponsors, employees of other radio stations in the Evansville/Vincennes metropolitan areas, the members of their immediate families (spouse, parent, sibling, or child), and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Entrants are responsible for complying with these Official Rules.

b. Listeners are eligible to win a prize from the Station only once every *thirty (30) days*, and listeners are eligible to win a prize in a Promotion conducted by the Station only once every *sixty (60) days if the prize is valued over \$600* and only once per year if the prize is valued over *\$1,000*. Only *one (1) winner per household* is permitted in any Station promotion. The Station may waive this stipulation if deemed appropriate.

c. The winners may be required to present valid government-issued photo identification and must provide their complete address, date of birth, and phone number to claim a prize, unless otherwise stipulated.

d. Entrants are required to provide truthful information, and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

PRIZES

a. Up to <u>2 prizes</u> will be awarded during this contest. The prizes will consist of:

 <u>Two (2) tickets to the Nitro Circus event at the Fishers Event Center in Fishers,</u> <u>Indiana, on December 1, 2024.</u>
<u>The Approximate Retail Value ("ARV") of each prize is \$62 per pair (\$31 per ticket).</u>

The total value of all four (4) tickets is \$124.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize. The prize is awarded as is. Tickets are valid only for the event on **December 1, 2024**. Tickets are not refundable and may not be substituted or exchanged for cash or credit at any time. Lost or stolen tickets will not be replaced. Tickets may not be sold to a third party.

b. The winner will need to come to the Station to pick up their prize and will be required to make arrangements to pick up their prize during normal operating hours or by appointment as available. All prizes or prize certificates for this contest will be picked up at the station. The winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.

c. The Prize(s) is not transferable, and no substitution, assignment, or cash equivalent of prize is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value.

d. Only **one winner per household** is permitted in this contest. A listener may not win this contest if a member of his/her family or household has won this Station contest within **30 days**.

POTENTIAL WINNER SELECTION AND NOTIFICATION

a. Decisions of the Station management with respect to the Promotion are final. b.

Winners will be selected as described in Section 1 of these Official Rules. c. Odds of

winning a prize depend in part upon the number and order of entries received.

d. Once selected, Prize winners will be notified by phone and/or instant message through Facebook. Prizes will be awarded only upon confirmation of eligibility and completion of all requisite releases.

CONDITIONS

a. Payments of all federal, state, and local taxes are solely the responsibility of the winner. The winner may be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize.

b. Participation in the Promotion and/or acceptance of prize constitutes entrant's and/or winner's permission for the Station or its agents to interview the winner(s), to photograph, film, and record each winner (or guest, if applicable), and to use in commerce and in any media now or hereafter known throughout the world in perpetuity, his/her name, prize won, hometown (city and state), biographic information, likeness, photograph, voice, audio or video recording, and/or any statements made by him/her regarding the Station, the Promotion, and/or its sponsor(s) for purposes of trade, publicity, or promotion without notice or additional compensation.

Participation in the Promotion and/or acceptance of prize constitutes entrant's and/or winner's (and guest's, if applicable) agreement to release, discharge, and hold harmless the Promotion's sponsor(s), the Station, its licensee, their respective parent, subsidiary, and affiliated entities, their advertising and promotional agencies, prize suppliers, and participating sponsors, and their respective officers, shareholders, directors, employees, agents and representatives, and all of their successors and assigns (collectively, "Released Parties") from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

d. The Released Parties are not responsible for any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable), including any results thereof.
