Official Contest Rules

1. HOW TO ENTER

a. The "Virtual Valentine Dance Family Season Pass Giveaway" contest (the "Contest") will begin on Sunday February 14, 2021 at 6:00PM Eastern Time ("ET") and end Sunday February 14, 2021 at 9:00 PM ET (the "Contest Period").

Tune into Blazer 91.1 WVUB or online wvub.org (the "Station") during the Contest Period during the Virtual Family Valentine Dance. Fill out the online form by visiting wvub.org or texting "DANCE" to 812-888-4337. (Standard message rights might apply). You will then receive the link to the online form during the hours of 6:00 p.m.-9:00 p.m. during the contest period. Once the text has been received by the station, the listener will receive an automated text back with a link to an online form. The listener may complete the form to be entered into the contest. The form is also available at wvub.org Information from the form will not be sold to any other parties.. Listeners may enter as many times as they wish. The winner will be randomly selected at 8:45 a.m. on the following Monday, February 15, 2021 following the contest period. The winner will be notified by the station via phone call from the number from which they texted to receive a prize pack.

b. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.

c. For those listening to the Station stream on the Internet: Please be advised that you may be listening to a delayed stream of the radio signal, which may vary depending on your computer's memory capacity and your connection. For that reason, we strongly recommend that you tune your radio to the Station to participate in this or any other call-in contest to be sure you are participating in "real time." The Station assumes no responsibility for contestants not making timely phone calls to the station as a result of the delays in the Internet stream.

d. There is no limit to the number of times a listener may attempt to call or qualify, but a listener may only win once every thirty (30) days from any contesting from the Blazer of a grand prize with and (ARV \$100+).

2. ELIGIBILITY RESTRICTIONS

a. The contest is open to all persons who reside within the Over the Air coverage area of WVUB-FM. Employees of the Station, its licensee, and affiliates, its advertising and underwriting agencies, participating sponsors/promotional partners, other radio stations in the Evansville metropolitan area and

the members of their immediate families and/or households are ineligible to participate or win. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

b. Only one winner per household is permitted in this contest. A listener may not win this contest if a member of his/her family or household has won this Station contest within 30 days of a grand prize (ARV \$100+).

3. PRIZE

a. One (1) Prize Pack will be awarded in this contest. An unlimited amount of qualifiers will be taken for this contest. The prize will be awarded in no particular order to qualifying contestants. The winner will be chosen by a random at 8:45 a.m.ET the following Monday at the end of the contest period. The ARV is \$150 for a Family Season Pass to Rainbow Beach Aquatic Center for the 2021 season. The prize is non-transferable or exchangeable.

b. The winner will need to go to Vincennes City Hall to pick up their prize and will be required to make arrangements to pick up their prize during normal operating hours or by appointment as available, 812-882-2785. All prizes or prize certificates for this contest will be picked up Vincennes City Hall located at 201 Vigo St. Vincennes, IN 47591. The winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.

c. There is no substitution, transfer, or cash equivalent for prizes, except that station may at its sole discretion, substitute prizes of comparable value or cash. b. Unlimited qualifiers will be taken each Thursday during the contest period.in accordance with Section 1a of these rules.

d. Winners must listen to win, but need not be present to win.

e. Winner needs to listen to Station to win. Winner must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited.
