NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

- 1. HOW TO ENTER
- These rules govern the Ticket Giveaway ("Blazer's Merry, Bright & Grand Giveaway"), which is being conducted by WVUB-FM. The Promotion begins on Friday October 27, 2023 and end Friday December 15, 2023.

- 5. The Promotion will be carried out via on-site registration. During the contest time period; listeners may go to the First City Staffing locations and fill out the registration form. The winner's name will also be announced on-air and publicized through the station's digital media platforms, including social media sites and website.
- 6. All six (6) winners will be selected from all of the non-duplicated submissions prior to the announcement of the winners on Friday December 15, 2023 at the Vincennes First City Staffing location.
- 7. A maximum of six (6) prize packs will be awarded for this contest.
- 8. Vincennes University Broadcasting WVUB FM known as The Blazer 91.1 WVUB will in no way be liable or responsible for the failure of any phone, other calling instrument, computer, vehicle/transportation to on-site registration, or other device, no matter the reason for the person's inability to complete the registration process.

WINNERS

- 1. There will be a maximum of 6 winners. A list of winners will be kept as part of this record following the conclusion of the contest.
- 2. The winners will be asked to coordinate with the designated staffer to retrieve contact information and then arrange for the prize to be picked up. The winner's name will also be announced on-air and publicized through the station's digital media platforms, including social media sites and website.
- 3. The winners may be required to present valid government-issued photo identification and must provide their complete address, date of birth and phone number to claim a prize.
- 4. Winners will be required to sign a release form and confirmation of receipt of the prize.

ELIGIBILITY RESTRICTIONS

- The Promotion is open to all persons who are 18 years of age or older and who
 reside in the geographic listening area of the station. Employees of Vincennes
 University Broadcasting, the Station, the Station's Underwriting Agent
 (collectively, "Promotion Entities"), their respective parent, subsidiary and
 affiliated entities, Station's advertising and promotional agencies and
 participating sponsors, other radio stations in the Evansville/Vincennes
 metropolitan areas, the members of their immediate families (spouse, parent,
 sibling or child) and those living in the same household of each (whether related
 or not), are ineligible to enter or win. This Promotion is subject to all applicable
 federal, state and local laws and regulations and is void where prohibited. Entrants
 are responsible for complying with these Official Rules.
- 2. Listeners are eligible to win a prize from the Station only once every thirty (30) days, and listeners are eligible to win a prize in a Promotion conducted by the Station only once every sixty (60) days if the prize is valued over \$600 and only once per year if prize is valued over \$1,000. Only one (1) winner per household is permitted in any Station promotion.

- 4. Prize packs will only be awarded to winners whose mailing address falls within the local listening area. Winners outside of the listening area, and those who listen online to wvub.org, are eligible to participate, but unable to receive the prize pack.

PRIZES

- Up to 6 prize packs will be awarded during this contest. The prize will consist of a gift card with a \$1,000 value donated by First City Staffing. The Approximate Retail Value ("ARV") of each Prize pack is \$1,000.
- 2. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize. The prize is awarded as is. If a prize-related event does not take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Promotion Entities, their sole responsibility to the winner will be to award the remaining available elements of the prize, if any and no substitution or compensation will be provided for the un-awarded elements of the prize.
- 3. No more than the stated number of prizes specified in these official rules will be awarded.

Entrants acknowledge that the Promotion Entities have not made, nor are in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties expressed or implied, in fact or in law, whether now or hereafter enacted concerning any prize, including without limitation, implied warranties of quality, mechanical condition, or fitness for a particular purpose, except for any express manufacturer's warranty as may be included with the prize or as may be separately provided to participants by law.
- 6. Other restrictions may apply.

POTENTIAL WINNER SELECTION AND NOTIFICATION

- 1. Decisions of the Station management with respect to the Promotion are final.

The winner must execute and return any required affidavit of eligibility and/or liability/publicity release. If a potential winner cannot be contacted or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
