APPENDIX

The following amendment was motioned by Councilman Lebas, seconded by Councilman Comeaux, and duly resolved and adopted on this 3rd day of August, 2020:

To amend Chapter 10, Article I, Section 10.1, as follows:

Current Text listed below is repealed in its entirety:

Section 10.1. Trash fires Restricted:

- (a) It shall be unlawful for any person to start or set any trash fire including, but not limited to branches, leaves, tires, paper, grass or debris where such fire is not protected by an approved incinerator, similar to that of the American Insurance Association marked P-1, within the municipality limits.
- (b) Whoever starts or sets a trash fire within the municipal limits without protection by a proper incinerator shall be punished as provided in section 1.8 of this code.

Current Text is replaced with the following:

Section 10.1. Trash fires Restricted:

- (a) It shall be unlawful for any person to start or set any open fire or to burn any grass, leaves, brush or debris within the municipal limits of the Town of Church Point. Provided however, this shall not apply to the following:
 - (1) Fire pits with a screen cover or man-made pits no larger than 5 feet in diameter which burns logs only and is located, constructed, maintained and used as to minimize fire hazards and smoke nuisance; approved fire pits are subject to extinguishment if a complaint is received by the Church Point Fire Department due to excessive smoke; and providing that burn be constantly attended and there is always an accessible water source available to extinguish the fire; and
 - (2) Agricultural open burns in fields.

- (3) In isolated areas, open burning may be conducted at a location at least 150 feet from the adjacent property line, providing that burn be constantly attended and there is always an accessible water source available to extinguish the fire.
- (b) Whoever violates the provisions of this section shall be fined not less than \$50 plus court costs nor more than \$300.00 plus court costs and shall be summoned to the town's mayor's court in connection therewith.

THIS ORDINANCE SHALL BECOME EFFECTIVE UPON THE MAYOR'S SIGNING SUCH AND UPON THE PUBLISHING OF SUCH IN THE CHURCH POINT NEWS.
