### APPENDIX

## ORDINANCE No. 071221-1

# AN ORDINANCE DEFINING, REGULATING, AND CONTROLLING THE PRESENCE OF CERTAIN ANIMALS WITHIN THE CITY LIMITS OF CHURCH POINT.

**WHEREAS**, The Board of Alderman for the Town of Church Point recognizes all of its rights, duties, and obligations to regulate and maintain the safety, peace, and welfare of the public;

WHEREAS, The Town of Church Point deems it necessary to protect the heath, safety, and welfare of the public, in part by regulating and controlling the presence of certain animals and livestock within the city limits;

**WHEREAS**, the Town of Church Point, makes and adopts the following findings and purposes::

## Section 1: Animal Regulations

- A. Residents are permitted to possess and maintain one horse per acre and a minimum of one-half (1/2) acre for each additional horse.
- B. Residents are permitted to possess and maintain one cow per acre and a minimum of one-half (1/2) acre for each additional cow.
- C. Residents are permitted to possess and maintain four sheep per acre.
- D. Residents are permitted to possess and maintain two goats per acre.
- E. Residents are permitted to possess and maintain chickens, ducks and birds. Such must be kept in a cage or fence in order to prevent free range and roaming beyond the resident's property. Roosters must be kept in a cage overnight that must be at least 150 feet from the closest neighboring residence or occupied building.
- F. Residents are permitted to possess and maintain up to three adult dogs, over the age of 8 months, per household. Dogs must be fenced in or on a leash while on the resident's property. Dogs must be held on a leash by a person while outside of the resident's property. Dogs are permitted to be off a leash while inside the confines to the town's dog park but must be supervised at all times by the dog's guardian.
- G. Residents are not permitted to possess or maintain potbelly pigs above 75 lbs. within the city limits.

H. No animal shall cause a nuisance to any resident in the town. Three complaints made by a person within a 30 day period shall permit a citation and summons for an animal causing a nuisance. The Court will determine whether that animal constitutes an actual nuisance which unreasonably disturbs the peace, welfare and safety of the public.

## Section 2: Penalties

- A. Any person who violates any provisions of this ordinance shall, upon conviction by a court of competent jurisdiction, be fined any amount up to \$100.00 or imprisoned for not more than ten (10) days for a first offense.
- B. Any person who violates any provisions of this ordinance shall, upon conviction by a court of competent jurisdiction, be fined any amount up to \$250.00 or imprisoned for not more than twenty-five (25) days for a second offense.
- C. Any person who violates any provisions of this ordinance shall, upon conviction by a court of competent jurisdiction, be fined any amount up to \$500.00 or imprisoned for not more than fifty (50) days for a third offense.
