An Ordinance adopting an Operating Budget of Revenues and Expenditures for the fiscal year beginning October 1, 2023 and ending September 30, 2024—See attached Budget FYE 09/30/2024.
BE IT ORDAINED BY THE BOARD OF ALDERMEN OF TOWN OF CHURCH POINT, LOUISIANA, in general session convened that:
SECTION 1: The attached detailed estimate of Revenues for the fiscal year beginning October 1, 2023 and ending September 30, 2024, be and the same is hereby adopted to serve as an Operation Budget of Revenues for the Town of Church Point, during the same period.
SECTION 2: The attached estimates of Expenditures by departments for the fiscal year beginning October 1, 2023 and ending September 30, 2024, be and the same is hereby adopted to serve as a budget of Expenditures for the Town of Church Point during the same period.
SECTION 3: The adoption of this Operating Budget of Expenditures be and the same is hereby declared to operate as an appropriation of the amount therein set forth within the terms of the budget classification.
SECTION 4: Amounts are available for expenditures only to the extent included with the 2023-2024 budget.
SECTION 5: The Mayor of the Town of Church Point shall have the authority to make changes within each department's operating budget to the extent that the department's total budget allocation is not modified without approval by the governing authority (Board of Aldermen). Modifications which change a department's total budget allocation must be approved by the Board of Aldermen. Additionally, all modifications to budgeted capital outlay must be approved by the Board of Aldermen.
SECTION 6: The Ordinance also includes the approval of annual salaries for the elected and certain appointed city officials as per the attached schedule— See Salary Schedule attached.
