If you are running late with your application, it may be dropped off in a sealed envelope for Monty Murry at The Murry Law Office, 3918 Texas Blvd, Texarkana, TX 75503. We do not want to omit any application, but we will be unable to consider any application that is not received by 5:00 pm on the deadline date.

Our grant application and allocation criteria are summarized on the application, so please read carefully to ensure you meet all requirements. Grant applications will be reviewed and rated based on the project funded by the grant. As a civic organization aimed at helping children and the disabled, those projects with the most direct impact to children and the disabled will be ranked with the greatest weight. Requests for operational expenses will not be considered. This year, we are also requiring all grant recipients to provide a report in November of 2022 on the progress of the grant received. Please ensure you are willing and able to comply with this request.

Requests for funding from the Kiwanis Club of Texarkana Kiwanis Foundation must be received no later than **April 29, 2022, by 5:00 PM.**

Grant applicants will be notified of decisions on or about June 1, 2022. Grants will be awarded at the Kiwanis Awards Banquet to be held on July 22, 2022.. Additional details regarding the banquet will be provided to grant recipients upon notification of award.

THE FOLLOWING CRITERIA ARE TAKEN INTO CONSIDERATION THROUGHOUT THE GRANT ALLOCATION PROCESS:

- 1. Our focus is primarily on projects/programs that benefit children and the disabled in our area. However, consideration will be given to other requests as well that impact those in need within our community.**
- 2. The number of individuals in our local community that will be affected throughout the life span of each grant issued is considered.**
- 3. Proposals will be accepted from 501(c)(3) or school based organizations, if the proposal is aligned with Kiwanis Club of Texarkana's mission.**
- 4. The impact of the project should be felt in the local community and by the target population beyond the funding period.**
- 5. The Kiwanis Club of Texarkana Foundation does NOT provide funding for reducing existing debt, coverage of overhead expenses, capital campaigns, or to purchase buildings or other real estate.**

Please note that grant recipients will be required to provide Kiwanis with an update over the next 12 months on the use of the grant funds. The update should include a measurement of the success of the program/project for which the grant funds were used, or an outline of the progress of the program if it is still in implementation. Before applying, please ensure you are willing and able to comply with this requirement. The update will be requested in November of 2022.
