On or about October 13, 2020, in the Town of Orono, County of Penobscot, State of Maine, Defendant Alyssa Dau did knowingly vote in the name of another, in that the Defendant did vote using an absentee ballot issued in the name of Evangelia Suleiman, all in violation of 21-A M.R.S. § 674(3)(C).

COUNT 2 FORGING THE NAME OF ANOTHER ON AN ABSENTEE BALLOT RETURN ENVELOPE
