Procedures for Phase 2 of the reopening of extracurricular activities for JMCSS
Target Date July 30 2020

Phase two is based on which activities can occur based on the TSSAA calendar.

- 1.) All activities that are allowed by the TSSAA calendar can take place.
- 2.) The following procedures still must take place in JMCSS.

Procedures that must be followed for every activity

- 1.) Temperature taken by a touchless thermometer and not to exceed 99.9 degrees. If a student's temperature exceeds 99.9, isolate the students from others, contact parents and the student should stay home until they are 24 hours fever free without any medication for fever reduction for all participants including Coaches and Sponsors
- 2.) Questions to be asked of all adults and students prior to and on arrival to campus:
 - A.) Have you had a fever of 100.0 degrees in the last 72 hours
 - B.) Have you had an unusual cough or shortness of breath?
 - C.) Have you had a loss of taste or smell?
 - D.) Have you been in close contact with anyone that has tested positive for Covid 19
 - E.) Have you been in close contact with anyone that has been tested and waiting on results for Covid 19
 - F.) Have you had vomiting or diarrhea in the last 24 hours?
 - G.) Parents are encouraged to perform the same checks before students arrive on Campus
 - H.) All participants must wear a mask at any time they are within six feet of anyone, unless there is physical activity that involves endurance.
- 3.) All locker rooms and showers will be closed. Participants will come dressed for the activity
- 4.) There must not be any use of shared water distribution. Water can be brought by participants that only they touch or distributed by Coaches in water bottles that must be discarded after use.
- 5.) All equipment must be cleaned and sanitized after use and between participants use

- 6.) All equipment must be cleaned and sanitized before the next groups enters for activity
- 7.) All students that are participating in JMCSS Extracurricular events must have a signed Athlete Consent form with signatures of the athlete and the parent/guardian
- 8.) Everyone that is dropping off or picking up a student athlete must remain in their vehicles
- 9.) There are to be no spectators at any of the practices.
- 10.) All Documentation of temperature checks and screenings must be maintained by the Coaches and be assessable if needed.
- 11.) Any student athlete that has symptoms that warrant being test for Covid-19 is to inform their coach as soon as possible. The Coach will then contact their Athletic Director/Principal and they will contact District Ad Tim Gilmer as soon as possible.

Please understand that is a District decision as to which phase of reopening we are in. This can change at any time and we will always do what is in the best interest of our School Community's safety and health.

Athletic Contest Procedures

The information provided below is based on a series of public meetings in the JMCSS community to discuss the reconfiguration of schools in the Covid-19 era

All TSSAA, State and local mandates will be followed. As the mandates change, so will our policies and procedures

- Non-essential personal (spectators) will be allowed to attend JMCSS Athletic events under the following conditions :
- 1.) All Fans Must be screened before entry is allowed (Tempatue checks)
- 2.) Each school will determine the number of spectators they can host while maintaining social distancing practices for the home seating and the visitor seating. Available seating must be determined by using group seating that will allow groups that arrive together to be seated together, with groups being separated by six feet in all directions. The schools will determine the maximum number of each group. Each group will be escorted to their seats.
- 3.) All spectators must wear face masks
- 4.) All spectators must remain seated except when visiting the restroom or concession stand
- 5.) No spectators are to stand along the fence line or behind the end zones. (see number 3)
- 6) No spectators are to be on the playing fields or courts before or after the games
- 7.) They will be no reentry if a spectator leaves the contest
- 8.) All ticket sales will be online. There are companies that provide this service if we cannot do it locally
- Band
- 1.) Band members that are virtual students or Cyber School students can report to campus for music/band class if it is necessary for the Band to function.
- 2.) Bands shall be allowed to play and preform at Home Games.
- 3.) Bands will not travel to away games
- 4.) JCMSS Schools will not host visiting bands for our home games.
- Concession Stands will be allowed to operate if the following measures are followed
- 1.) Concession Stands must have social distance measures in place that keep customers six feet apart.
- 2.) Concession Stands need to try to limit the items that are not pre-packaged. No condiments will be offered for self-service
- 3.) if possible set up debit card devices so that no cash is exchanged.
- At this time there will be no restriction on bus travel as far as social distancing
- Schools will need to decide if the band will be the stands or if they will provide alternative seating
- Just as visiting schoos will be at the mercy of our schools, we will be at their mercy when we travel. Contact them as soon as possible and let them know how many tickets they will be allowed to purchase and our policies when the visit, and what policies we will have to follow when we visit.
- We have to have very clear directives on what must happen when a participant in a contest is confirmed with Covid-19. The Coach is to let the school administration know as soon as possible

and the school administration is to let our District AD know as soon as possible. Our District AD will let Annett Wilson know. We will then follow district policy on how to follow up. (when this policy is developed)

- All essential personnel will be screened upon arrive to the stadium school personnel
