

## OFFICIAL CONTEST RULES

(updated 12/14/16)

A complete copy of these rules can be obtained by visiting (or requested via mail – please provide a self-addressed, stamped envelope) the offices of WRSA-FM Mix 96.9, 8402 Memorial Parkway SW, Huntsville, Alabama 35802. Our office hours are Monday through Friday, 8am until 5pm.

1. All contests are open to the general public except for employees, agents, subsidiaries and affiliates of NCA, Inc., participating sponsors, their immediate families and household members.
2. As a licensee of the FCC and a trustee of the public airwaves, Mix 96.9 reserves the right to interrupt and/or discontinue a contest or promotion at any time without any advanced notice to the public.
3. Stations reserve the right to limit the number of times an individual may enter a contest or drawing, and set age limits/restrictions for participants.
4. An individual may win any contest (on-air and online) only once per sixty (60) day period unless otherwise specifically stated, and only one winner per household, every sixty (60) days. In the event that a person wins more than one time within the 60 day period, the latest prize will be forfeited.
5. Contests in which the prize includes overnight accommodations, a cash prize greater than \$600, or any combination thereof, an individual may win only one (1) promotion per calendar year. Contestants and winners for these prizes must be 21 years of age or older. Any overnight accommodations (unless otherwise specified) are non-transferable, and must be used on the date(s) specified in the contest or on the certificate.
6. A 1099 will be issued for cash prizes greater than or equal to \$600. All state, local, federal and/or other taxes, duties, tariffs, title fees, licensing fees or other fees for prizes awarded become the sole responsibility of the winner. All participants agree to provide Mix 96.9 their name, address, phone number and social security number. Failure to supply the required information makes the contestant ineligible. This information will ONLY be used for processing necessary information as it pertains to prizes, and will be destroyed after a period of time required by law.
7. Prize winners agree to waive any claim of royalty, right of further compensation for any such promotional use and agree not to appear on, or on behalf of, any other radio or television station for a period of six (6) months after acceptance of prize.
8. All prizes are awarded "as is". The station reserves the right to substitute prizes if necessary.
9. No purchase is necessary to participate or win. Void where prohibited by law.
10. Gifts/Prizes are non-transferable and cannot be exchanged.
11. All entry blanks, forms, devices and materials, as well as all the information contained on or within) that is gathered during the course of entry shall become the property of the station to be used, disposed of or destroyed at the discretion of the station.
12. All entrants and winners agree that NCA, Inc. (dba WRSA-FM Mix 96.9) may broadcast or publish their name, city of residence, photo, video, film or any other likeness, including their voice, recorded or live, for any reason they deem necessary without compensation and further agrees to hold NCA, Inc. and it's stations blameless and without liability for such publication, broadcast or use.

13. All entrants and winners also agree that NCA, Inc. (dba WRSA-FM Mix 96.9), and their affiliates, shall have no liability and shall be held blameless for any injury, misfortune, or damage to either persons or property insured by entering, participating in, winning or losing any contest by use or non-use of any prize received.

14. The station reserves the right to issue particular rules pertaining to contests and they shall be considered part and parcel of these Official Contest Rules.

15. The announcer on-air or the person conducting the drawing or contest will determine all winners, and their decision shall be final.

16. All prizes won will be available for pick up after noon the day following (cash prize winners will be notified when available). Prizes must be claimed in person (or by a designated alternate) at the studio between regular business hours, and within thirty (30) days, excluding holidays – unless other arrangements are made. Proper identification must be presented to claim prizes and winners will be asked to sign a disclaimer stating they have received their prize and understand that they are eligible to win again after sixty (60) days. Children who win designated contests must be accompanied by a parent to redeem prize. If prize is not picked up within thirty (30) days, ownership of said prize(s) reverts back to the station to be disposed of at the sole discretion of the station with the winner losing all claims and rights to said prize, and they are still considered a contest winner and must adhere to the rules of eligibility.

17. Members of the Mix 96.9 VIP Club may have the “Unfair Internet Advantage” with promotion and contest information, which is emailed to them at random times. Additionally, Mix 96.9 reserves the right to, at its discretion, announce on-air clues when necessary.

Violations of these rules or attempts to win any contest by fraud, deception, or cheating shall be grounds for the station to disqualify that individual from participating in all current and future contests, promotions and events at the sole discretion of the station as well as forfeiture of any prize(s) won by fraudulent means.

19. All calls on the contest line are recorded for possible playback use.

NCA, Inc. assumes no responsibility for: listeners/winners inability to get through on the contest line(s) due to failure of equipment, power failure or access to [www.mix969huntsville.com](http://www.mix969huntsville.com); events which are canceled and/or rescheduled; replacing tickets/prizes already won to the canceled events; replacing lost or stolen prizes or substituting prizes in the event participating sponsors/vendors do not provide prizes as promised.
