#### East Carolina Radio's EEO outreach menu option activities include:

Establishment of an ongoing internship program designed to assist members of the community to acquire skills needed for broadcast employment. Internship opportunities include involvement in board operation, live remote broadcasts, sports play-by-play announcing, downloading spots and PSA announcements into automation system, and affidavit processing. Current internship scheduled to occur between February and May 2021 was canceled due to the Covid-19 pandemic. This internship program was to include sports play by play shadowing, studio board operations, and studio automation training. (FCC EEO outreach category #5).

Co-sponsorship of one job fair with organizations in the business and professional community whose membership includes substantial participation by women and minorities. Co-sponsored the Currituck Business Expo & Job Fair on March 2, 2021 at the Currituck County High School. Provided pre-event radio promotion for the event, set up employment display the day of the event, provided employment applications, and invited attendees to submit those applications. Station participants: Local Sales Manager and Local Sales Representative. The attendance at the event was very poor due to the Covid-19 pandemic and no employment applications were submitted.
