2) How to Enter: Contest begins Wednesday March 15<sup>th</sup> at 12:00am CST and ends Friday April 7<sup>th</sup>, 2023, at 11:59PM CST.

a. Listeners can go to any local participating Boost mobile store ([click here for location list](#)) and locate the Summer Experience Ad located near the main register counter in the store. To enter listeners must scan the QR code with their smart phone and enter all necessary information. Information must be complete to qualify.

Note: Incomplete submissions will be disqualified.

3) Winner Selection: Limit one entry per person/household/email address. 5 winners will be selected from all eligible entries by station panel and contacted on or before Friday April 7<sup>th</sup>, 2023. The Company is not responsible for entries not received due to service outage or delays, computer issues, difficulty accessing the internet, and other technical problems. The Company and Released Parties (as defined below) are not responsible for delayed, misdirected, incomplete, lost, late, undeliverable, illegible, damaged, stolen, or garbled entries or communications, regardless of cause.
