Contest Period #2 Begins 12am CST Friday March 20<sup>th</sup>, 2026 & ends 10am CST Friday October 17<sup>th</sup>, 2025. At the end of each Contest Period, two (2) essays will be selected as the potential winners by a committee of qualified judges consisting of WPWX programming and promotions staff as selected in Sponsor's sole discretion, based on the following criteria ("Criteria"): (1) entry clarity and composition (25%); and (2) compelling reasons that the entrant gives to receive (75%). The Entry with the two highest cumulative scores for each such Contest Period will be designated the winning Entries of that Contest Period. All non-winning Entries from each Contest Period will be considered in each subsequent Contest Period. A maximum of four (4) winners will be selected for the Aggregated Contest Period.
