

CONTESTANT RULES & REGULATIONS

WBHK-FM 24 DAYS OF KISSMAS 2020

CONDITIONAL PRIZE CONTEST November 30th 2020 – December 23rd 2020

There is no purchase necessary to enter or win the contest. Void where prohibited.

1. WBHK-FM will conduct the contest Sunday – Saturday according to the above listed dates at 10AM, 1PM, and 7PM (Monday-Friday), 11am & 4pm (Saturday), and 1pm & 6pm (Sunday) for a chance to win a 24 Days of Kissmas prize.
2. WBHK-FM reserves the right to end the contest at any time without additional notice.
3. Contestants may win a maximum of one (1) time during the entire length of the promotion. A maximum of one (1) winner per household will be allowed for this entire promotion. Employees of other radio stations or radio broadcast companies, SummitMedia LLC. employees, associates, and interns of WBHK-FM, other related sponsors, and their immediate families may not participate and are not eligible to win. The term “immediate families” includes spouses, grandparents, parents, siblings, children, and grandchildren.
4. To participate in the contest, listen to 98.7 Kiss FM WBHK November 30th, 2020 – until all prizes are won (The contest period) to play. Listen for the cue to call and be the 9th caller to our contest line (205)-741-0987. Once caller #9 has been selected, the caller will be asked to pick two numbers between 1 and 48. If the two numbers picked by the caller have the same prize they will win the prize that is listed on those two numbers. If the numbers do not have the same prize, the caller will not win a prize and will be eligible to play the contest at another time.
5. Immediately following the cue to call, WBHK-FM will accept the 9th caller and that caller will become the official contestant for that individual game.
6. Once the official contestant has been selected, the station disc jockey then will ask the contestant to pick two numbers between 1 and 48. If the two numbers picked by the caller have the same prize they will win the prize that is listed on those two numbers. If the numbers do not have the same prize, the caller will not win a prize and will be eligible to play the contest at another time. If the caller correctly matches two prizes, they become the official winner of that contest.
7. Any winning contestant must be at least 18 years old and the participant who originally dialed the phone to the radio station to participate in the contest. No family members, friends, office associates, or any other person will be allowed to participate in the contest on another person’s behalf. The contestant must provide their own name, birth date, and social security number. If a contestant uses a false name, birth date, or social security number, they will be immediately disqualified from the contest and be ineligible to win any prize, and such conduct may be considered insurance fraud and may result in termination from all future SummitMedia LLC. contest and legal ramifications.
