POST-ARREST COMPLAINT Charge 1: MURDER - DOMESTIC VIOLENCE (ATTEMPT) Charge 2: MURDER (ATTEMPT) I responded to the above address to assist deputies with a complaint call in regards to the above subject shooting his seven year old son. Shortly after arrival, deputies located the above subject walking back to the residence from a wooded area behind the residence. The above subject was detained and a search warrant was obtained and executed at the residence. During the search nineteen 223/5.56 shell casings were located in the front yard of the residence. An AR-15 rifle was located inside of the residence with ten rounds in the magazine and one round inside the chamber. The rifle was on fire when deputies recovered it. The victims were located in Cave City, Ky, by Officer Brandon Fletcher with CCPD. BCSO Deputy James Roberts responded to assist CCPD and learned that the vehicle had multiple bullet strikes to include two in the windshield area and one around the side window of the vehicle. The vehicle was occupied by the above's estranged wife, son, and two other individuals at the time of the shooting. An interview was conducted on the above subject and he stated that he was mad at his estranged wife because of a picture he observed on her google account. He also stated that he was mad when she showed up to pick up the child with another male subject with her. He indicated that he ran into the front yard to get a good line of sight so that he could shoot at the vehicle and believed that he wanted to kill who he believed was his estranged wife's new boyfriend. None of the individuals inside of the vehicle were directly struck by any of the bullets. However, one individual did sustain an injury to his head as a result of the shooting.
