In the event the first caller does not get the correct titles and artists the station will move on to the following caller and so on until we have a winner. <u>Time Delay Between</u> **Over-the-Air Signal and Internet/Streaming Broadcast**: Due to the time delay that exists between the Station's over-the-air signal and the Station's online/streaming webcast, listeners who listen to the Station online/via streaming service may hear the cue to call later than listeners listening to the Station's over-the-air signal. As a result, the ability of an online/streaming listener to enter the Promotion on-air may be diminished.
