

77 WABC'S "THOUSAND DOLLAR MINUTE" CONTEST OFFICIAL RULES

No purchase is necessary to enter or win; a purchase will not improve your chances of winning

These Specific Rules, in addition to the General Rules [<https://wabcradio.com/contest-rules/>], govern **77 WABC's "Thousand Dollar Minute" Contest** (the "Contest"). The General Rules contain additional terms and conditions that govern and apply to the Contest and are incorporated herein by reference. A complete copy of these Specific Rules can be obtained by visiting the Station Office during normal business hours Monday through Friday (excluding holidays) or by sending a self-addressed, stamped envelope with a request for the rules to Red Apple Media, 2nd Floor, New York, NY 10022. In the event of a conflict or inconsistency between these Specific Rules and the General Rules, these Specific Rules shall govern. Any individual who enters, attempts to enter or in any way participates or attempts to participate in the Contest agrees to be bound by these Specific Rules and the General Rules as well as by all interpretations of the rules by the Station and/or Red Apple Media, Inc. ("Red Apple") and by all other decisions of the Station/Red Apple which are final and binding in all matters relating to the Contest.

1. **No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.**
2. **Eligibility.** This Contest is open only to persons aged eighteen (18) years or older at the time of entry with a valid Social Security number or taxpayer ID, who are legal residents of the 50 states of the United States or the District of Columbia or Puerto Rico, and who have not won more than three (3) different prizes from the Station in the last thirty (30) days. Employees of Red Apple Media, Inc., its affiliates, related entities and subsidiaries, Contest sponsors, prize providers, advertising agencies, other radio stations serving the New York DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents, siblings, and children (including "step"-relations of any of the foregoing).
3. **Contest Period.** Contest will begin on Tuesday, March 22, 2022, at 4:00am and will run until Friday, December 30, 2022, at 5:00am (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
4. **How to Enter.**

On-Air: Listen to the Station on a weekday (Mondays through Fridays) from 4:00 AM to 5:00 AM during the Contest Period. When the Station announces or alerts callers to call the Station for a chance to win the Grand Prize, listeners should call the Station at 1-800-848-WABC (9222). Caller number seven (7), as determined by the Station in its sole discretion, will have the opportunity to play the game. The participant will have to answer ten (10) questions correctly in sixty (60) seconds to win the Grand Prize (as defined below). Other prizes are given if participants answer five (5) or more questions correctly. **Time Delay Between Over-the-Air Signal and Internet/Streaming Broadcast:** Due to the time delay that exists between the Station's over-the-air signal and the Station's online/streaming webcast, listeners who listen to the Station online/via streaming service may hear the cue to call later than listeners listening to the Station's over-the-air signal. As a result, the ability of an online/streaming listener to enter the Contest on-air may be diminished.

5. **Winner Selection.** As described above, a randomly selected caller, as determined by the Station in its sole discretion, will be eligible to play the game. The participant will have to answer ten (10) questions correctly in sixty (60) seconds to win the Grand Prize. If the participant answers eight (8) or nine (9) questions correctly in sixty (60) seconds, then he or she will win a Small Prize (as defined below). If the participant answers five (5) to seven (7) questions correctly in sixty (60) seconds, then he or she will win a Consolation Prize (as defined below). (Subject to verification of eligibility and compliance with the terms of these Specific Rules and the General Rules). The Grand Prize winner will be contacted using the email address and/or telephone number provided with the entry. The Grand Prize winner will be required to fill out, sign and return to Red Apple, within seven (7) business days of the date the documents are sent, a winner declaration and IRS tax form. Such documents must be signed and returned in order for the winner to claim his or her prize.
6. **Odds of winning.** The odds of winning will depend on participants' knowledge of the trivia questions.
7. **Prize(s). Grand Prize(s):** The Grand Prize consists of a cash award of one thousand dollars (\$1,000.00) to be mailed by check to the address provided by the winner. The Small Prize consists of a one-hundred-dollar (\$100) gift card to be mailed to the address provided by the winner. The Consolation Prize consists of a WABC hat to be mailed to the address provided by the winner.
