

**77 WABC'S  
"GOLF FOR GOOD WITH ANDREW CHARITY CONTEST"  
OFFICIAL RULES**

These official contest rules ("Official Rules"), in addition to the General Rules [<https://wabcradio.com/contest-rules/>], govern 77 WABC's "**GOLF FOR GOOD WITH ANDREW CHARITY CONTEST**" (the "Promotion"), sponsored by Red Apple Media Inc. and Crystal Springs Resort.

The General Rules contain additional terms and conditions that govern and apply to the Promotion and are incorporated herein by reference. A complete copy of these Official Rules can be obtained by visiting 77 WABC ("the Station") office during normal business hours Monday through Friday (excluding holidays) or by sending a self-addressed, stamped envelope with a request for the rules to 77 WABC, 800 Third Avenue - 2nd Floor, New York, NY 10022. In the event of a conflict or inconsistency between these Official Rules and the General Rules, these Official Rules shall govern. Any individual who enters, attempts to enter or in any way participates or attempts to participate in the Promotion agrees to be bound by these Official Rules and the General Rules as well as by all interpretations of the rules by the Station and/or Red Apple Media, Inc. ("Red Apple") and by all other decisions of the Station/Red Apple which are final and binding in all matters relating to the Promotion.

1. **No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.**
2. **Eligibility.** This Promotion is open only to persons aged eighteen (18) years or older at the time of entry with a valid Social Security number or taxpayer ID, who are legal residents of the 50 states of the United States or the District of Columbia or Puerto Rico, and who have not won more than three (3) prizes from the Station in the last thirty (30) days. Employees of Red Apple Media, Inc., its affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the New York DMA, and the immediate family members and household members of all such employees are eligible to participate but are not eligible to win prizes as described below. The term "immediate family members" includes spouses, parents, siblings, and children (including "step"-relations of any of the foregoing).
3. **Promotion Period.** Promotion will run from April 14, 2024 (8:00 AM ET) through the conclusion of that day's Fourth Round (the "Promotion Period") of that weekend's PGA golf tournament taking place in Augusta, Georgia (the "Tournament"). The Station's computer is the official time keeping device for this Promotion.

4. **How to Enter.**

The Promotion will begin accepting entries from qualified individuals ("Entrants") on March 25, 2024 at 12:00 PM ET and will cease accepting entries on April 10, 2024 at 2:00 PM ET, or upon the Promotion reaching its 100-box capacity (the "Entry Period"), as explained below. Entrants will receive the full "grid" with their positioning via email prior to, or at the beginning

of the Tournament, and the full grid will be posted at [wabcradio.com/golf](http://wabcradio.com/golf). The publicly posted version of the grid will only include initials for privacy purposes.

To enter the Promotion, Entrants must visit [wabcradio.com/golf](http://wabcradio.com/golf) and donate \$25.00 to the WABC Radio Foundation, Inc. (Federal Tax ID Number: 86-3988037) to be donated to Tunnel to Towers earmarked for their mortgage payoff for Office Diller's Family. For every \$25.00 donated to the not-for-profit organization, an Entrant will receive one “box,” randomly selected by the Station at its sole discretion, each with equal odds of winning.

Entrants must include their name, e-mail address, and age in order to enter and submit an entry. Each Entrant may complete a maximum of five (5) entries each. Any individual Entrant who exceeds this maximum via one or more aliases will be ineligible to win prizes.

All money donated as part of this Promotion will be donated to the Prostate Cancer Fund by WABC Radio Foundation, Inc.<sup>1</sup>

**5. Winner Selection.**

The full “grid” consists of 10 (ten) vertical columns and 10 (ten) horizontal columns, both numbered from 0 (zero) to 9 (nine).

This Sample Grid is for illustrative purposes and may not represent official Promotion template.

Once the full “grid” is filled with Entrants, each entry will be randomly assigned a “square” at the intersection of a vertical column and horizontal row which correspond to numbers, as illustrated above.

The winner will be determined automatically at the conclusion of the Tournament, based on the “box” on the “grid” at the intersection of the last digit of the Fourth Round score of the first and second place finishers for the Fourth Round of the Tournament, based on the corresponding horizontal and vertical numbers, respectively. Results of the complete Tournament are not a factor for this Promotion.

**For example, if Player A finishes with a Fourth Round-best score of 68, and Player B finishes with a Fourth Round second-best score of 69, the winning digit for the horizontal direction of the grid would be “8” and the winning digit of the vertical direction of the grid would be “9.” As a result, the winning Entrant would be the entrant with a “square” at the intersection of 8 (horizontal) and 9 (vertical).**

In the event that there is a tie for best score in the Fourth Round of the Tournament, the second digit of the tied first-place score will be the winning digit for both the first and second place winners with respect to the grid.

As such, for example, if Player A and Player B both score a Fourth Round-best 68, the winning digit for the horizontal and vertical directions of the grid would be “8” and the winning Entrant will be the entrant with a “square” at the intersection of 8 (horizontal) and 8 (vertical).

6. **Odds of winning.** The odds of winning the prize will be 1% per entry, corresponding with the one hundred (100) combinations of the digits 0-9 zero and horizontally, as illustrated on the Sample Grid above.
7. **Prize(s).** There will be one (1) winner. The eligible Entrant with box that is located at the intersection of first and second place, as detailed above, will be the winner.

The winner will win an 18-hole round of golf with 77WABC Radio’s Andrew Giuliani at Crystal Springs Resort, 1 Wild Turkey Way, Hamburg, NJ 07419 (the “Prize Round”), for one (1) individual the winner and two (2) guests selected by the winner at his/her sole discretion (equaling 3 total individuals).

The approximate retail value of the total prize is \$450.00, representing the average 18-hole round of golf for three (3) individuals at Crystal Springs Resort in Hamburg, New Jersey (price estimate is subject to various factors).

All results are unofficial until winner is/are verified by the Station. Prizes may not be exchanged, substituted, transferred or redeemed for other prizes by winner. Cash will not be awarded as a substitute for the prize. The Station reserves the right to substitute a prize in its sole discretion without an on-air or off-air announcement, in which case a prize of equal or greater value will be awarded. Other terms and conditions may apply.

The scheduling of the Prize Round is subject to Andrew Giuliani’s availability. The Prize Round must be scheduled for a date prior to September 1, 2024.

Winner and guests are responsible for their own transportation to and from Crystal Springs Resort.

**Conditions for Acceptance of the Prize(s).** The winner will be notified via email. The prize(s) must be claimed via response to notification email by 4:30 PM ET on April 22, 2024 or it will be forfeited. Failure by the winner to respond to the Station's messages, calls, e-mails or other notifications will lead to forfeiture of the prize. Failure to completely fill out and sign all waivers, releases, or forms requested by the Station (if applicable) will result in forfeiture of the prize. Upon forfeiture of the prize, the Station has the right to award that prize to another winner using the method described above. A winner who forfeits any prize is not eligible to win another Promotion conducted by the Station for thirty (30) days.
