

It is your responsibility to renew this license if you intend to conduct small games of chance after May 27, 2022. Please let us know if you have any questions.

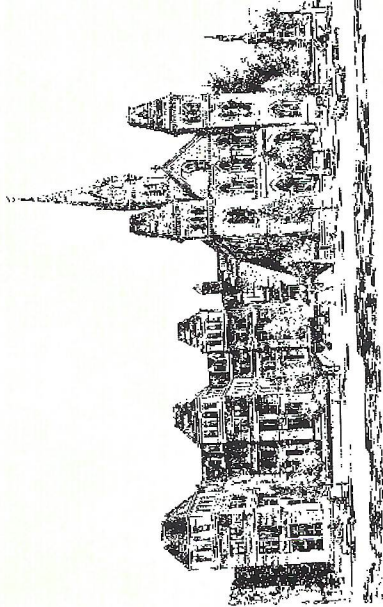
