AN ORDINANCE OF THE CITY OF MCLEANSBORO REVISING AND AMENDING CHAPTER 43 (MOTOR VEHICLE SCHEDULES), MORE SPECIFICALLY SCHEDULE "F" (LIMITED PARKING ZONES) AND ALL PREVIOUS ORDINANCES AND RESOLUTIONS AMENDING SAID SCHEDULE ADOPTED BY THE CITY OF MCLEANSBORO, ILLINOIS.

WHEREAS, the City of McLeansboro, Illinois, is authorized direct and control the roadways within its corporate boundaries; and

WHEREAS, the City Council of McLeansboro, Illinois previously adopted Chapter 43 of the McLeansboro City Code, specifically Schedule "F" which identified those areas within the City that have limited parking zones; and

WHEREAS, the City Council of McLeansboro, Illinois believes that the previously adopted Schedule "F" (Limited Parking Zones) is in need of modification for the best interests of the citizens of McLeansboro and visitors to the City and said Schedule "F" should be revised and amended.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE OF THE CITY OF MCLEANSBORO, STATE OF ILLINOIS, THAT CHAPTER 43, SCHEDULE "F" (LIMITED PARKING ZONES) IS HEREBY REVISED AND AMENDED TO PROVIDE AS FOLLOWS:

SCHEDULE "F"

LIMITED PARKING ZONES

In accordance with the provisions of **Section 24-6-4(C)**, the following streets are hereby designated as limited parking zones, to-wit:

I. TWO HOUR PARKING.

It shall be unlawful to park any vehicle for a longer period of time than **two (2) hours** between the hours of **eight o'clock (8:00) A.M.** and **six o'clock (6:00) P.M.** from Monday through Friday and between the hours of **eight o'clock (8:00) A.M.** and **eight o'clock (8:00) P.M.** on Saturday, on any street, alley or public way upon the following described boundaries:

There shall be no parking of vehicle of any kind on Jerry Sloan Ave. from Cherry and Market Streets except that parking of passenger automobiles only is permitted on the west side of Pearl St., between the points specified herein, from the hours of **four thirty o'clock (4:30) P.M.** to **seven o'clock (7:00) A.M.**

Parking on both sides of that portion of Pearl St. from Market St. north **one-half (1/2) block** to an alley be prohibited from the hours of **seven o'clock (7:00) A.M.** to **three o'clock (3:00) P.M.** Monday through Friday. **(Ord. No. 554; 09-13-83)**

II. TRUCK PARKING.

Parking Prohibited. It shall be unlawful at any time for any motor truck larger or heavier than a **three-fourths (3/4) ton** pick-up truck, except vehicles loading or unloading as provided for in subsection (B) hereof, to be parked or left standing on the Public Square in the City. **(Ord. No. 341; 03-09-54)**

Double Parking. Trucks shall be permitted to double park on the streets bounding the Public Square for the purpose of loading or unloading merchandise and when it is impossible to load or unload at the rear of the premises receiving or shipping the merchandise. **(Ord. No. 239; 03-23-48)**

1. ALL provisions contained in Chapter 43, Schedule "F" of the City of McLeansboro, Illinois, not specifically mention in this Ordinance shall remain in full force and effect.
2. This Ordinance shall take full force and effect immediately upon passage by the Corporate Authorities.
