## CLASSIC ROCK 92 ONE KELLI'S ROCKS N' SOCKS (Week 2 12/9-13) OFFICIAL RULES

1. Dates/Eligibility. Classic Rock 92 One presents Kelli's Rocks in Socks (the "Contest") which begins Monday, December 2, 2019 and will end when all Rocks N' Socks Matches are given away, or on Friday, December 20, 2019 (whichever comes first).
